

US-27 IMPROVEMENTS PROJECT IN MIRAMAR, PEMBROKE PINES AND SOUTHWEST RANCHES

Project Overview

The Florida Department of Transportation awarded a \$8.5 million contract to Ranger Construction, for roadway improvements along US-27 from the Miami-Dade/Broward County Line to Griffin Road. The length of the project is approximately 7 miles. Construction will begin April 18, 2017 and is expected to be completed summer 2018.

Project Improvements

- Removing old asphalt and resurfacing the mainline travel lanes, shoulders, median crossovers, and access roads
- Cross slope correction
- Widening of existing outside 4-foot paved shoulders to provide a 7-foot buffered bicycle lane in both directions
- Widening of existing northbound right-turn lanes at the intersections of Pembroke Road, Taft Street, and Stirling Road
- Provide paved shoulders along the Griffin Road median crossover at the intersection with US-27
- Addition of rumble striping along the northbound and southbound edge lines
- Minor signalization improvements
- Installation of audible pedestrian crossing signals at the intersection of Johnson Street
- Addition of internally illuminated street name signs at the intersections of Johnson Street and Griffin Road
- Installation of eight permanent traffic monitoring sites
- New lighting at the intersection of Sheridan Street, and additional lighting between Pines Boulevard and Johnson Street to close the gap between both intersections
- Installation of new signing and pavement markings

Traffic Impact

- At least one lane in each direction will remain open during construction.
- Lane closures can be expected along US 27 from the Miami-Dade/Broward County Line to Griffin Road.
- The speed limit may be reduced along US 27 from Miami-Dade/Broward County Line to Griffin Road throughout construction
