### LOXAHATCHEE ROAD MOBILITY IMPROVEMENTS PROJECT MONTHLY PROGRESS REPORT

The City of Parkland, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT design and construct the Loxahatchee Road Mobility Improvements Project through the City of Parkland Resolution Numbers 2016-510, 2021-011, and 2021-018.

### ANTICIPATED CONSTRUCTION ACTIVITIES FOR THE MONTH OF APRIL 2024

- Loxahatchee Road will be fully closed between SR 817/ N University Drive and Parkside Drive; detour signs will be in place directing motorists
- Drainage operations will continue within the full closure limits and from west of N University Drive to Nob Hill Road
- Sheet pile wall installation will continue within the full closure limits
- Excavation and embankment operations for roadway widening will continue from west of Bishop Pit Road to west of N University Drive

### PROJECT IMPROVEMENTS

Project improvements include widening the road to accommodate bike lanes, creating a continuous sidewalk on the south side of the road, constructing roundabouts at Nob Hill Road, University Drive, and Parkside Drive, adding an additional eastbound left turn lane onto SR 7/US 441, milling and resurfacing the roadway, and upgrading signage and pavement markings.

**Construction Cost:** \$33,480,584

**Construction Start Date:** October 30, 2023

**Anticipated Completion:** Early 2027
