### SR 9/I-95 AT SR 824/PEMBROKE ROAD INTERCHANGE IMPROVEMENTS

The Florida Department of Transportation (FDOT) District Four, has awarded a contract to Halley Engineering, Inc., for improvements along the SR 9/I-95 on and off-ramps at the SR 824/Pembroke Road Interchange.

Construction Cost: \$1,465,257 Construction Start Date: September 25, 2019 Anticipated Completion: Summer 2020

#### PROJECT IMPROVEMENTS

- Widening the I-95 off ramps at Pembroke Road to accommodate an additional right turn lane.
- Minor shoulder widening of the I-95 on ramps at Pembroke Road.
- Upgrading the existing traffic signals at the intersections of Pembroke Road and the I-95 off ramps.
- Upgrading the existing lighting along the I-95 on and off ramps at Pembroke Road to LED lighting.
- Reconstructing the sidewalks and pedestrian crossings at the I-95 off ramps and the I-95 northbound on ramp at Pembroke Road.
- Milling and resurfacing within the project limits.

#### TRAFFIC IMPACTS

- The shoulder along the I-95 northbound off ramp to Pembroke Road will be closed during construction for widening operations.
- Single lane closures along the I-95 on and off ramps at Pembroke Road will occur overnight, Sunday through Thursday, between 9:00 p.m. and 5:30 a.m.
- Full ramp closures of the I-95 off ramps to Pembroke Road will occur overnight, Sunday through Thursday, between 9:00 p.m. and 5:30 a.m. for asphalt paving operations, lighting, and signal improvements.
- Single lane closures along Pembroke Road at the I-95 Interchange will occur overnight, Sunday through Thursday, between 9:00 p.m. and 5:30 a.m.
- Additional lane closure and detour information will be provided in the weekly traffic report distributed by FDOT.
