



DISTRICTWIDE OVERHEAD ALUMINUM SIGN REPLACEMENT PROJECT

Project Overview

The Florida Department of Transportation has awarded a \$1.6 million contract to Florida Safety Contractors, Inc., to replace overhead aluminum signs throughout Broward, Palm Beach, and Martin counties. Construction will begin September 12th, 2016 and is expected to be completed by Summer 2017.

Traffic Impact **this information is subject to change due to inclement weather and other unforeseen conditions**

- The following lane closures are expected for each of the sign locations, unless otherwise noted below.
 - One lane in each direction may be closed Monday through Friday between the hours of 9 a.m. and 4 p.m.
 - Two lanes may be closed Sunday through Thursday between the hours of 12 a.m. and 6 a.m. adjacent to the sign installation location.

Project Improvements

Improvements under this contract include replacement of the following 18 overhead aluminum signs and sign structures:

Broward County

- **Eastbound Hollywood Boulevard roundabout east of S 26th Avenue in Hollywood**
- **Westbound Hollywood Boulevard roundabout west of S 26th Avenue in Hollywood**
- **Northbound US 1 south of Sheridan Street in Dania Beach**
- **Southbound US 1 north of Dania Beach Boulevard in Dania Beach**
- **US 1 north of Sunrise Boulevard in Fort Lauderdale**
 - Motorists can expect a full closure of US 1 north of Sunrise Blvd that will occur Monday through Thursday between the hours of 12 a.m. and 6 a.m.
- **US 1/Sunrise Blvd and NE 18th Avenue in Fort Lauderdale**
 - Motorists can expect a full closure of US 1/Sunrise Blvd and NE 18th Avenue that will occur Monday through Thursday between the hours of 12 a.m. and 6 a.m.
- **Eastbound SR 84 west of SW 26th Terrace in Fort Lauderdale**
 - Motorists can expect a full closure of SR 84 west of SW 26th Terrace that will occur Monday through Thursday between the hours of 12 a.m. and 6 a.m.
- **Westbound SR 84 west of SW 18th Terrace in Fort Lauderdale**
 - Motorists can expect a full closure of Westbound SR 84 west of SW 18th Terrace that will occur Monday through Thursday between the hours of 12 a.m. and 6 a.m.

- **Eastbound SR 84 east of SE 4th Avenue in Fort Lauderdale**
 - Motorists can expect a full closure of eastbound SR 84 east of SE 4th Avenue that will occur Monday through Thursday between the hours of 12 a.m. and 6 a.m.
- **Northbound SR 7 south of Oakland Park Boulevard in Lauderdale Lakes**
- **Southbound SR 7 north of Oakland Park Boulevard in Lauderdale Lakes**
- **Eastbound Copans Road west of the I-95 overpass in Pompano Beach**
- **Westbound Copans Road east of the I-95 overpass in Pompano Beach**
 - Access will be maintained to the I-95 Ramp during lane closures.

Palm Beach County

- **Northbound SR 805/S Dixie Highway south of Lake Avenue in Lake Worth**
- **Southbound SR 805/N Dixie Highway between Lucerne Avenue and Lake Avenue in Lake Worth**
- **Westbound Glades Road west of Airport Road in Boca Raton**
- **Westbound Palmetto Park Road east of the ramp to I-95 NB ramp in Boca Raton**

Martin County

- **Southbound SR 707/NW Dixie Highway north of the St. Lucie River bridge in Stuart**
 - No traffic impact expected.
