### SR 5/FEDERAL HIGHWAY MOBILITY IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT) District Four will improve mobility along SR 5/Federal Highway from SR 834/Sample Road to the Broward/Palm Beach County Line in the cities of Lighthouse Point, Pompano Beach and Deerfield Beach. This project will address mobility improvements by widening the roadway to accommodate bike lanes and reconstructing medians, portions of the roadway and sidewalks.

The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. The Broward MPO is a federally-mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward. ### PROJECT IMPROVEMENTS

- Widening the roadway to accommodate 5-foot bike lanes in each direction.
- Reconstructing median, portions of the roadway and sidewalks.
- Modifying median access at NE 41<sup>st</sup> Street.
- Milling and resurfacing of the roadway.
- Upgrading signalization and lighting at NE 2<sup>nd</sup> Street/Eller Street.

### TRAFFIC IMPACTS

- Intermittent single lane closures will occur until the project is completed.
- Double lane closures may occur 10:00 a.m. to 4:00 p.m. or 8:00 p.m. to 8:00 a.m.
- Lane closures will not be permitted in school zones during school zone hours.
- Access to residents and businesses will be maintained at all times.
