NORTH BROWARD MOBILITY IMPROVEMENTS PROJECT

This mobility improvement project consists of milling and resurfacing, installing sidewalks, and adding signage and pavement markings to accommodate pedestrians and cyclists along NE 11th Avenue, NE 48th Street/NE 49th Street, SE 2nd Avenue and SW 3rd Avenue in Deerfield Beach and Pompano Beach. Other improvements include curb and gutter, pavers, new driveways, and lighting upgrades.

PROJECT IMPROVEMENTS

- NE 11th Avenue from SR 814/Atlantic Boulevard to NE 6th Street: Installing missing sidewalk on the west side of the road; adding shared roadway pavement markings
- NE 48th Street/NE 49th Street from SR 845/Powerline Road to SR 5/US 1: Milling and resurfacing to accommodate bike lanes in each direction; minor widening between Dixie Highway and SR 5/US 1
- SE 2nd Avenue from SR 869/SE 10th Street to SR 810/Hillsboro Boulevard: Adding shared roadway pavement markings
- SW 3rd Avenue from SR 869/SW 10th Street to SR 810/Hillsboro Boulevard: Milling and resurfacing; installing shared roadway pavement markings; adding pedestrian lighting

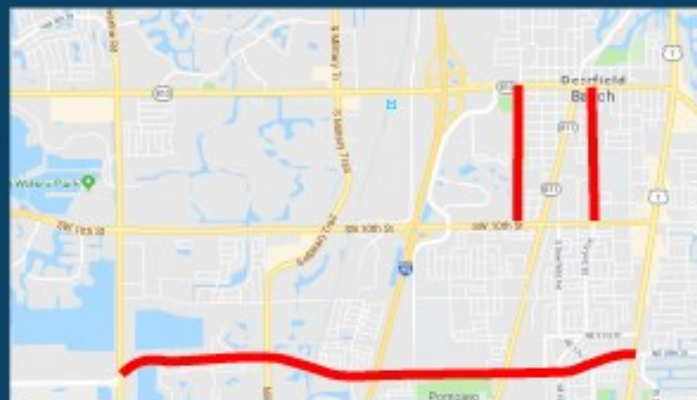

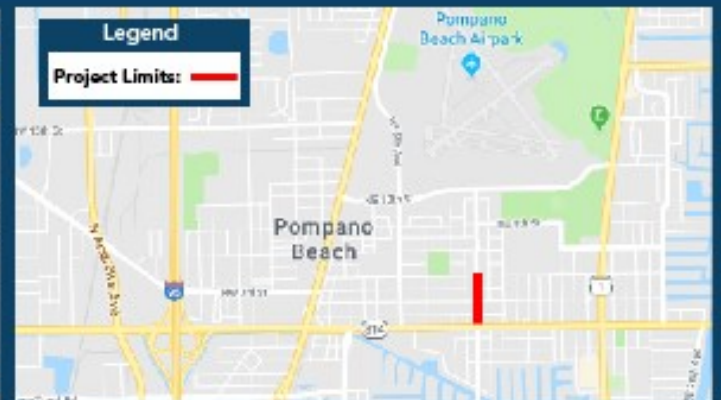
TRAFFIC IMPACTS
