



**BROWARD MOBILITY PROJECT  
IN FORT LAUDERDALE,  
LAUDERHILL, TAMARAC  
LAUDERDALE LAKES,  
AND OAKLAND PARK**

## Project Overview

The Florida Department of Transportation (FDOT) awarded a \$15 million contract to Construct Group Corp. for the construction of sidewalks, multi-use pedestrian paths, and bicycle lanes along 45 roadways in Broward County, which began construction February 2, 2015 and will be completed in early 2019.

This project is part of a larger \$100 million investment from the Broward Metropolitan Planning Organization (MPO) to provide bicycle, pedestrian, and public transportation access throughout the Broward region. ## Project Improvements

### Fort Lauderdale and Lauderhill:

NW 31 Ave. from Broward Blvd. to Sunrise Blvd.

- Removing old asphalt and resurfacing the corridor
- Adding 4-5 foot wide bike lanes in each direction

### Fort Lauderdale, Lauderhill, Lauderdale Lakes, and Oakland Park:

NW 31 Ave. from Sunrise Blvd. to Oakland Park Blvd.

- Removing old asphalt and resurfacing the corridor
- Adding 4-5 foot wide bike lanes in each direction
- The 45 mph speed limit will be permanently reduced to 35 mph.

### Oakland Park, Lauderdale Lakes, Tamarac, and Fort Lauderdale:

NW 31 Ave. from Oakland Park Blvd. to Commercial Blvd.

- Removing old asphalt and resurfacing the corridor
- Adding 4-5 foot wide bike lanes in each direction
- The 45 mph speed limit will be permanently reduced to 35 mph.

## Construction Update

Construction along NW 31 Avenue is ongoing. Resurfacing has been completed from Broward Boulevard to Oakland Park Boulevard. Remaining activities in this area include the installation of signs and application of final pavement markings. Resurfacing along NW 31 Avenue from Oakland Park Boulevard to Commercial Boulevard begins July 15 and is expected to be completed in mid-October.

## Traffic Impact

Single lane closures can be expected Monday through Friday between 9 a.m. and 4 p.m. and Sunday through Thursday between 9 p.m. and 5 a.m.
