## State Road 15 Resurfacing Project

The Florida Department of Transportation (FDOT), District Four, will host a Construction Open House for the roadway resurfacing project from south of Morgan Road to south of Shirley Drive in the City of Pahokee.

Construction Cost: \$3,861,123

Construction Start: March 15, 2020

Anticipated Completion: Late 2020

#### PROJECT IMPROVEMENTS

- Roadway resurfacing from south of Morgan Road to south of Shirley Drive
- Guardrail replacement
- Installation of new signage and pavement markings

### **TRAFFIC IMPACTS**

- State Road 15, from Hooker Highway to Shirley Drive, will be closed to through traffic from Sunday, March 15, 2020 to Sunday, November 15, 2020; however, local traffic will still be able to access State Road 15 during both phases of construction from either the northbound or southbound direction, depending on the current construction phase
- Motorists and pedestrians may detour via State Road 15, State Road 715, and Hooker Highway
