PROJECT PURPOSE

The Resurfacing, Restoration and Rehabilitation (RRR) project will extend the service life of the pavement, enhance roadway safety, and improve operating characteristics of the corridor.

PROJECT IMPROVEMENTS

- Repaving the existing roadway.
- Widening shoulders to accommodate 8foot buffered bike lanes (from St. Paul of the Cross Catholic Church to south of Portage Landing North).
- Restriping to provide designated bike lanes (from south of park entrance to St. Paul of the Cross Catholic Church)
- Reconstructing pedestrian sidewalk curb ramps.
- Upgrading lighting and pedestrian signalization at the intersection of Lost Tree Village/Old Harbour Road.
- Traffic signal replacement to mast arm system.
- Replacing and upgrading of signage impacted by construction.

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the inconvenience to the community.
- Lane closures using flaggers will occur during non-peak hours to minimize impacts on traffic.
- Access to residents and businesses will be maintained at all times during construction.
