SR 804/Boynton Beach Boulevard Improvements Project

The Florida Department of Transportation (FDOT), District Four, will host a Construction Open House for the improvements project on SR 804/Boynton Beach Boulevard, from west of Jog Road to Congress Avenue, in the City of Boynton Beach and unincorporated Palm Beach County.

Construction Cost: \$8,369,134

Construction Start: August 8, 2019

Anticipated Completion: Early 2021

PROJECT IMPROVEMENTS

- Milling and resurfacing, minor widening for bike lane installation, sidewalk, curb and gutter reconstruction
- Median safety improvements (including partially closing the median opening at Pear Tree Circle)
- Installing directional turn lanes into Lime Tree Condominiums and Bent Tree Villas East
- Extending the existing turn lane at Bent Tree Drive
- Drainage, signage, and pavement marking upgrades
- Minor signalization and lighting improvements
- Limited tree removal to allow for median and bike lane safety enhancements

TRAFFIC IMPACTS

- One lane may be closed in each direction at any time.
- Two lanes may be closed in each direction, nightly, 9:00 p.m. until 6:30 a.m.
- Pedestrian access will be maintained at all times.

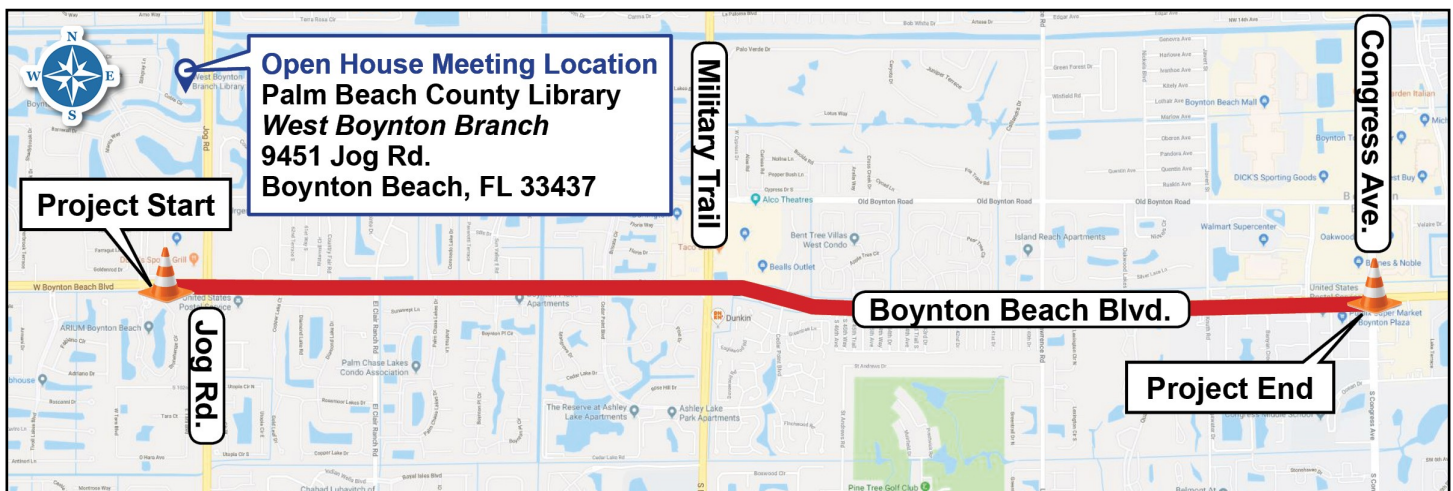
