State Road (SR) 804/Boynton Beach Boulevard Improvements Project From west of Jog Road to Congress Avenue in the City of Boynton Beach and unincorporated Palm Beach County

### SR 804/Boynton Beach Boulevard Improvements Project

The Florida Department of Transportation (FDOT), District Four, is pleased to provide a project update on SR 804/Boynton Beach Boulevard, from west of Jog Road to Congress Avenue, in the City of Boynton Beach and unincorporated Palm Beach County.

Construction Cost: \$8,369,134 Construction Start: August 8, 2019 Anticipated Completion: Winter 2021

#### **PROJECT UPDATE THROUGH JANUARY 2020**

- Work anticipated from November to December 2019: Median work will continue from Bent Tree Drive to Military Trail, including extending the existing turn lane at Bent Tree Drive. During this time, the inside lane may be closed around-the-clock in each direction.
- Work anticipated from mid-December 2019 to January 2020:
   Once the work at Bent Tree Drive is completed, the median opening at Pear Tree Circle will undergo a permanent partial closure to install directional turn lanes into Lime Tree Condominiums and Bent Tree Villas East. During these operations, the median access will be closed until the new directional turn lanes are completed.
- Please note these time frames are estimates, and could change based on inclement weather and unforeseen issues. Please see the graphics below depicting new median configurations and traffic patterns once this work is completed.

#### **WORK EXPECTED IN EARLY 2020**

- Median work is expected to continue moving west to east through early 2020.
- At this time, paving operations should not commence until the majority of the project has been completed in Fall 2020.




