State Road 60 Milling & Resurfacing Project

The Florida Department of Transportation (FDOT), District Four, will host a Construction Open House for the State Road 60 milling & resurfacing project from 38th Avenue to 21st Avenue in the City of Vero Beach. The Open House will be held from 4 p.m. until 6 p.m. at the Čity of Vero Beach City Hall in the Council Chambers Room, 1053 20th Place, Vero Beach, FL 32960. Project personnel will be on hand to discuss the scope of work, construction schedule, and address questions and comments one-on-one. Please note: There will not be a formal presentation. Guests may arrive at any time between 4 p.m. and 6 p.m.

PROJECT IMPROVEMENTS

This project is located in Indian River County within the City of Vero Beach. Improvements include:

- Milling and resurfacing of all travel lanes, and turn lanes
- Drainage improvements, including pipe installations, inlet replacements, pipe liner and curb & gutter installation
- Sidewalk and ADA ramp improvements
- Traffic Monitoring site rehabilitation

Construction Cost: \$2.07 million

- Pedestrian signalization upgrades •
- Installation of signing and pavement markings

TRAFFIC IMPACTS

Lane closures for work zones beyond 750' feet of the 27th Street intersection:

- There are no time restrictions for single lane closures
- No double lane closures are allowed between 11 a.m. and 7 p.m.

Lane closures for work zones within 750' feet of the 27th Street intersection:

- No single lane closures are allowed between 11:30 a.m. and • 6:30 p.m.
- No double lane closures are allowed between 6:30 a.m. and 9:30 p.m.
