



### **Project Overview**

**Purpose:** Construct a 10-foot-wide accessible multi-use trail with boardwalks.

Length: 6.8 miles

**Contractor:** Ferreira Construction Co., Inc.

Construction Start: July 26, 2023

Estimated Contract Cost: \$10.6 Million

**<u>Contract Time:</u>** 764 calendar days (not including weather and holidays)

**Estimated Completion:** Summer 2025


#### **Scope of Work - SUN Trail Improvements**

#### **SUN Trail Improvements**

- This segment of the Shared-Use Nonmotorized (SUN) Trail Network will be located within the Savannas Preserve State Park.
- The SUN Trail project improvements consist of constructing approximately 6.8 miles of 10-foot-wide accessible multi-use trail with boardwalk sections.








Existing East Coast Greenway Trail







### **Traffic Impacts & Construction Phasing**

### Maintenance of Traffic

- Work will be done in two major phases to minimize impacts to the construction corridor.
- Single-lane closures are permitted on Walton Road Monday through Sunday as follows:
  - Daytime, Monday through Sunday from 9:00 a.m. to 3:00 p.m.
  - –Nighttime, Sunday through Thursday from 9:00 p.m. to 5:30 a.m.
  - –Nighttime, Friday and Saturday from 11:00 p.m. to 7:00 a.m.



### **Construction Phasing**

### Phase 1

- Construct the shared-use path adjacent to SE Walton Road

### Phase 2

-Install pavement markings on SE Walton Road existing pavement



## **Safety and Local Coordination**

#### - Work Zone Signage & Maintenance of Traffic

- Advanced warning and project signage will be placed throughout the construction corridor to alert the traveling public
- Local Agency & Stakeholder Coordination
  - The project team will continue working closely with local stakeholders including local municipalities, schools, neighborhoods and other local agencies to ensure safety standards are met and impacts to the public are minimized in any way possible
- Emergency vehicles will be provided access at all times




