**FDOT TREASURE COAST TRAFFIC REPORT**  
**November 21 through November 28, 2014**

**TREASURE COAST** – Construction and maintenance-related lane closures on state highways in Martin, St. Lucie and Indian River counties are expected during the week of November 21 through November 28. Weather permitting, work will be done at the following locations throughout the Treasure Coast. **Due to the Thanksgiving holiday, lane closures have been suspended from 4 p.m. Wednesday, November 26 through 9 p.m. Sunday, November 30.** For updated lane closure information, please refer to [www.d4fdot.com](http://www.d4fdot.com). **CONSTRUCTION PROJECTS**  
**MARTIN COUNTY**

**1. CR 714 / Martin Highway from west of Mapp Road to west of the Florida's Turnpike Entrance**

**Description:** This 1.879-mile widening project consists of adding one lane in each direction and constructing a raised median with access points throughout the corridor. Additional

improvements include: constructing an 8' sidewalk and a 5' bike lane on both sides of the roadway; milling and resurfacing of existing lanes; drainage improvements, including building two retention ponds; sound wall installation at Sunset Trace; replacing the box culvert at Danforth Creek; and signage, signalization, landscape and lighting improvements. **Cost/Completion:** \$15.7 million. Completion is expected in fall 2016.

**Traffic Impact:**

- All lanes are open through November 28.
- Eastbound and westbound traffic on CR 714 / Martin Highway is shifted slightly north from Martin Downs Boulevard to SW Berry Avenue. The new traffic pattern opens a work zone for construction crews to complete the widening of SR 714 / Martin Highway and is expected to be in place until summer 2015.
- The following sidewalks along CR 714 / Martin Highway are closed for drainage and roadway reconstruction work:
  - The sidewalk along the south side of CR 714 / Martin Highway from SW High Meadows Avenue to SW Palm City School Avenue is closed through the summer 2015. Pedestrians should use the signalized crosswalks at the SW High Meadows Avenue, SW Berry Avenue and SW Palm City School Avenue intersections.
  - The sidewalk along the north side of CR 714 / Martin Highway from SW Palm City School Avenue to SW Mapp Road is closed through the summer 2015. Pedestrians should use the signalized crosswalks at the SW Palm City School Avenue and SW Mapp Road intersections.

**2. State Road 710 / Beeline Highway from east of the Florida East Coast Railway Crossing to east of SW Fox Brown Road**

**Description:** This 10-mile design/build project consists of widening the existing two-lane roadway to add two 1.5-mile passing lane segments, one in each direction. Other improvements include milling and resurfacing of the existing lanes and construction of new shoulders, guardrail installation, and drainage modifications.

**Cost/Completion:** \$6.92 million. Completion in early 2016.

**Traffic Impact:**

- Intermittent lane closures on SR 710 may occur Monday and Tuesday between 9 a.m. and 4 p.m. for maintenance repairs. A flag crew will maintain two-way traffic.

**3. Rest Area and Weigh-in-Motion Station Improvements in Martin and St. Lucie Counties**

**Description:** This project consists of the reconstruction of the exit ramps at the northbound and southbound Rest Areas in Martin County, the restriping of the northbound and southbound Rest Areas in St. Lucie County, and the restriping of the northbound and southbound Weigh in Motion Stations in Martin County. The approximate locations are as follows: Martin County Rest Areas, 3 miles south of SR 714 / Exit 110; St. Lucie County Rest Areas, 2 miles north of SR 68 / Exit 131; the northbound Martin County Weigh in Motion Station, 4 miles south of Bridge Road / Exit 96; and the southbound Martin County Weigh in Motion Station, 2 miles north of SR 714 / Exit 110.

**Cost/Completion:** \$786,542. Completion in spring 2015.

**Traffic Impact:**

- The southbound Martin County Weigh in Motion Station is closed until midnight Saturday, November 22.

**4. Big John Monahan Bridge on State Road 710 / Warfield Boulevard from SW Trail Drive to east of State Road 76 / Kanner Highway in Indiantown**

**Description:** Street lighting will be installed along Big John Monahan Bridge on SR 710 / Warfield Boulevard from SW Trail Drive to east of the entrance ramps to SR 76 / Kanner Highway.

**Cost/Completion:** \$ 337,659.30. Completion in early 2015.

**Traffic Impact:**

- Intermittent lane closures on SR 710 may occur Saturday, Monday and Tuesday between 7 a.m. and 7 p.m. for light pole installation on the bridge.

**5. I-95 Lighting Installation from Bridge Road to High Meadows Road**

**Description:** This 5.382-mile project includes installation of a new lighting system along both the northbound & southbound lanes of I-95 from north of CR 708 to south of High Meadows Road, and installation of eight pedestal mounted bridge poles on the bridge over the St. Lucie River.

**Cost/Completion:** \$2.8 million. Completion in summer 2016.

**Traffic Impact:**

- All lanes are open through November 28.

**ST. LUCIE COUNTY**

**6. Orange Avenue (County Road 68) from east of Graves Road to west of Kings Highway (SR 713)**

**Description:** This 5.62-mile-long project includes widening roadway shoulders; drainage improvements; drive reconstruction; and signing and pavement markings.

**Cost/Completion:** \$3.99 million. Completion in fall 2014.

**Traffic Impact:**

- One lane in either direction of Orange Avenue will be closed Saturday, Monday and Tuesday between 8 a.m. and 5 p.m. A flag crew will maintain two-way traffic.

**7. State Road A1A Bridge Rehabilitation over the FPL Discharge Canal in Jensen Beach**

**Description:** This 0.085-mile-long project includes replacing the existing concrete bridge deck and approach slabs, milling and resurfacing the roadway at the approach slabs, concrete spall repairs of the piles and pile caps, and installing a corrosion protection system to the piles and pile caps.

**Cost/Completion:** \$1.8 million. Completion in fall 2015.

**Traffic Impact:**

- All lanes are open through November 28.
- Traffic in both directions of A1A at the bridge is shifted slightly west to facilitate the bridge work. This traffic shift is expected to be in place until spring 2015.
- During this time, there will be no shoulders for bicyclists and pedestrians will not have sidewalk access across the bridge.

**8. Port St. Lucie Boulevard from Trenton Lane to Wayne Street in Port St. Lucie**

**Traffic Impact:**

- One westbound lane of Port St. Lucie Boulevard will be closed Monday and

Tuesday between 9 a.m. and 4 p.m. to install a temporary entrance.

## INDIAN RIVER COUNTY

### **9. I-95 from the St. Lucie/Indian River County line north to State Road 60 (Osceola Boulevard/Exit 147) at Vero Beach**

**Description:** I-95 is being widened from the St. Lucie/Indian River County line north to State Road 60 (Osceola Boulevard/Exit #147) at Vero Beach. Improvements in this 6.84-mile-long project include: adding one lane on I-95 in each direction; removing old asphalt and repaving the existing lanes; reconstructing the SR 60 interchange; reconfiguring turn lanes and adding traffic signals at the SR 60/94<sup>th</sup> Avenue intersection just west of I-95; replacing the I-95 bridges over 4<sup>th</sup> Street (Citrus Road), 90<sup>th</sup> Avenue and SR 60; traffic signal and highway lighting improvements; constructing sound barrier walls adjacent to the Lakewood Village, Department of Corrections Housing and Indian River Aerodrome communities; and landscaping.

**Cost/Completion:** \$54.4 million. Completion in fall 2014.

**Traffic Impact:**

- The speed limit on I-95 is 60 MPH at all times on the northern four miles of the project, from five miles north of Indrio Road (SR 614/Exit 138) to just north of State Road 60 (Exit 147).
- Motorists should be alert for slow moving construction vehicles entering and leaving the travel lanes.
- One lane in each direction of I-95 may be closed overnight Sunday through Tuesday between 9 p.m. and 6 a.m.
- One lane in either direction of SR 60 at the I-95 overpass may be closed intermittently Monday through Wednesday between 8:30 a.m. and 3:30 p.m.
- One lane in each direction of SR 60 at the I-95 overpass may be closed overnight Sunday through Wednesday between 8 p.m. and 6 a.m.
- One lane in either direction of 4<sup>th</sup> Street at the I-95 overpass may be closed periodically Monday through Wednesday between 7 a.m. and 6 p.m. Flag crews will maintain two-way traffic.
- Intermittent lane closures on 90<sup>th</sup> Avenue at the I-95 overpass will take place Monday through Wednesday between 7 a.m. and 6 p.m. Flag crews will maintain two-way traffic.
- Traffic is shifted on Oslo Road at the I-95 overpass for guardrail installation.

### **10. I-95 (SR 9) from just north of State Road 60 (Osceola Boulevard/Exit 147) at Vero Beach to the Indian River/Brevard County Line**

**Description:** I-95 is being widened from just north of State Road 60 to the Indian River/Brevard County line. Improvements in this 12.5-mile-long project include: adding one lane on I-95 in each direction; milling and resurfacing the existing lanes; signalization and lighting improvements; Intelligent Transportation System (ITS) improvements, including closed-circuit television cameras, Dynamic Message Signs and vehicle detectors; removal/replacement of the existing bridges over CR 512 (Fellsmere Road); construction of a noise barrier wall adjacent to the Encore Sunshine Travel RV Resort; and reconstruction of the interchange at CR 512, including the ramps and turn lanes. **Cost/Completion:** \$50.6 million. Completion in early 2016.

**Traffic Impact:**

- Motorists should be alert for slow moving construction vehicles entering and exiting the travel lanes.
- Eastbound motorists can expect intermittent delays up to 5 minutes on CR 512 from west of I-95 to east of I-95 Monday through Wednesday between 9 a.m. and 3 p.m. to transfer construction materials.
- One lane in either direction of SR 512 near the I-95 overpass will be closed overnight Monday through Wednesday between 9 p.m. and 6 a.m. Two-way traffic will be maintained, but traffic will be shifted in either direction to accommodate bridge work.

**11. U.S. 1 from north of Kings Highway in St. Lucie County to south of Oslo Road**

**Description:** Improvements that will be made in this 2.4 mile-long project include widening U.S. 1 in Indian River County from four to six lanes from the county line to Oslo Road, replacing the bridges over the Florida East Coast railroad tracks, installing new sidewalk on both sides of U.S. 1 in various locations, constructing sound walls on the west side of U.S. 1 in front of the Cypress Bay Mobile Home Park, upgrading traffic signals at the U.S. 1-Highlands Drive intersection, installing a new roadway drainage system, removing old asphalt and resurfacing U.S. 1, and installing landscaping.

**Cost/Completion:** \$23.2 million. Completion in spring 2015.

**Traffic Impact:**

- One lane in each direction of U.S. 1 will be closed intermittently Saturday between 7 a.m. and 5 p.m. and Monday and Tuesday between 9 a.m. and 4 p.m.
- One lane in each direction of Old Dixie Highway under U.S. 1 will be closed intermittently Saturday, Monday and Tuesday between 7 a.m. and 5 p.m. Flaggers will direct traffic.
- Southbound traffic on U.S. 1 south of Highland Drive is shifted onto the newly-constructed bridge. Traffic will remain in this configuration through spring 2015.
- Northbound traffic on U.S. 1 north of Kings Highway is shifted onto the newly-constructed bridge. Traffic will remain in this temporary configuration through spring 2015.

**12. SR 510 / Wabasso Causeway Bridges from the Wabasso mainland to Orchid Island in Indian River County**

**Description:** Improvements to be made in this .33-mile-long project include concrete spall repair of the damaged bridge deck, bridge beams, pile caps, and piles. Additional improvements will include installing a corrosion protection system to the bridge beams, pile caps, and piles. These improvements will restore damaged concrete surfaces and help guard against future bridge corrosion.

**Cost/Completion:** \$2.1 million. Completion in summer 2015.

**Traffic Impact:**

- All lanes are open through November 28.

**13. SR A1A / Sebastian Inlet Bridge at the Indian River County / Brevard County Line**

**Description:** The .251-mile bridge runs over the Sebastian Inlet in Indian River and Brevard Counties. Improvements include concrete spall repair of the bridge deck and beams and

replacing the north and south fishing piers.

**Cost/Completion:** \$1.63 million. Completion in spring 2015.

**Traffic Impact:**

- One lane in either direction of A1A / Sebastian Inlet Bridge will be closed Monday and Tuesday between 7 a.m. and 5 p.m. A flag crews will maintain two-way traffic.
