### SR A1A/South Ocean Boulevard Improvements Project

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the upcoming State Road SR A1A/South Ocean Boulevard Roadway Improvements project. This project aims to enhance the safety, resiliency, and longevity of the infrastructure in our communities.

Construction Cost: \$5.9 million Construction Start: April 2025 Anticipated Completion: Summer 2026

#### **PROJECT IMPROVEMENTS**


- Milling and repaving the roadway, including overbuild, to enhance infrastructure resilience and improve safety for the community
- Widening the roadway in both directions to accommodate 5-foot designated bicycle lanes in each direction to enhance bicyclist accessibility and safety
- Upgrading pedestrian signals with new LED countdowns at the intersection of SR A1A/ South Ocean Boulevard and SR 802/Lake Avenue to enhance pedestrian accessibility
- Installing a new traffic signal mast arm at the Palm Beach Par 3 Golf Course and a Rectangular Rapid Flashing Beacon (RRFB) at Phipps Ocean Park to improve pedestrian safety
- Upgrading curb ramps and replacing sections of the existing sidewalk, including replacing the asphalt sidewalk with concrete along the west side of SR A1A/South Ocean Boulevard, to improve pedestrian safety and connectivity
- Regrading swales for enhanced drainage capacity
- Upgrading signage and pavement markings, including installing green bicycle markings at the intersection of SR A1A/South Ocean Boulevard and SR 802/Lake Avenue to enhance visibility and safety

## TRAFFIC IMPACTS

- Work will occur in phases to minimize impacts to the public
- Daytime lane closures are permitted the Monday before Thanksgiving through May 1st, 9:00 a.m. until 5:00 p.m., Monday through Friday; all other times, 8 a.m. until 6 p.m., Monday through Friday
- Nighttime lane closures are permitted within 800-feet of SR 802/Lake Avenue from 8:00 p.m. until 7:00 a.m., Monday through Friday
- Lane closures will utilize flaggers to direct traffic as needed
- Sidewalk and curb ramp closures will be implemented as necessary, sidewalk detours will be provided
- Access to businesses and residences will be maintained at all times
