ROADWAY OPERATIONS

- Northbound roadway widening and drainage installation to commence

EARMAN RIVER BRIDGE OPERATIONS

- Production piles and rip-rap installation to be completed by November 15, 2025

UPCOMING MILESTONES

- Reconstruction of east side of the bridge, sidewalk, and curb and gutter
- Pile cap installation and deck placement for new northbound bridge
- Traffic railing installation on east face side of the Earman River Bridge

ACCOMPLISHED MILESTONES

- Traffic shift to the west side of the Earman River Bridge completed
- Test piles for the Earman River Bridge completed
- Channel excavation of east side of the Earman River Canal completed
