



Project Overview

<u>Purpose:</u> This project aims to enhance safety, accessibility, and long-term resiliency along S.R.15/East Main Street.

Length: 3.342 miles

Contractor: General Asphalt

Construction Start: November 2025

Estimated Contract Cost: \$3.5 Million

Estimated Completion: Summer 2026



S.R. 15/E Main Street in Canal Point, facing south (Pre-Construction)






Scope of Work – Roadway Improvements

Roadway Improvements

- Mill and resurface S.R. 15/East
 Main Street from Annona Street to
 south of S.R. 700/Conners
 Highway to ensure long-term
 infrastructure resilience and safety.
- Upgrade signing and pavement markings, including bicycle lane markings to enhance visibility and safety.

Scope of Work – Bus Stop and Sidewalk Improvements

Bus Stop Improvements

 Constructing six concrete bus pads throughout the project corridor to enhance transit rider safety and accessibility.

Sidewalk Improvements


 Installing curb ramps and replacing sections of sidewalk to enhance pedestrian safety and connectivity.



Northbound S.R. 15/E Main Street before the installation of a bus pad. (Pre-Construction)





Construction Phases

Phase 1

- Construct proposed sidewalks, curb ramps, driveways, and install detectable warning surfaces.
- Mill and repave the existing pavement along S.R. 15/E Main Street.

Phase 2

Place final pavement markings and signage.

Traffic Impacts

Maintenance of Traffic

- Work will occur in phases to minimize impacts to the public.
- Single-lane closures will be permitted daily, with flaggers in place to direct traffic as needed.
- Access to businesses and residences will be maintained at all times.

Safety and Local Coordination

- Public Safety is our Top Priority!
 - Work Zone Signage & Maintenance of Traffic
 - Advanced warning and project signage will be placed throughout the construction corridor to alert the traveling public.



- The project team will continue working closely with local stakeholders including local municipalities, schools, neighborhoods and other local agencies to ensure safety standards are met and impacts to the public are minimized in any way possible.
- Emergency vehicles will be provided access at all times


