



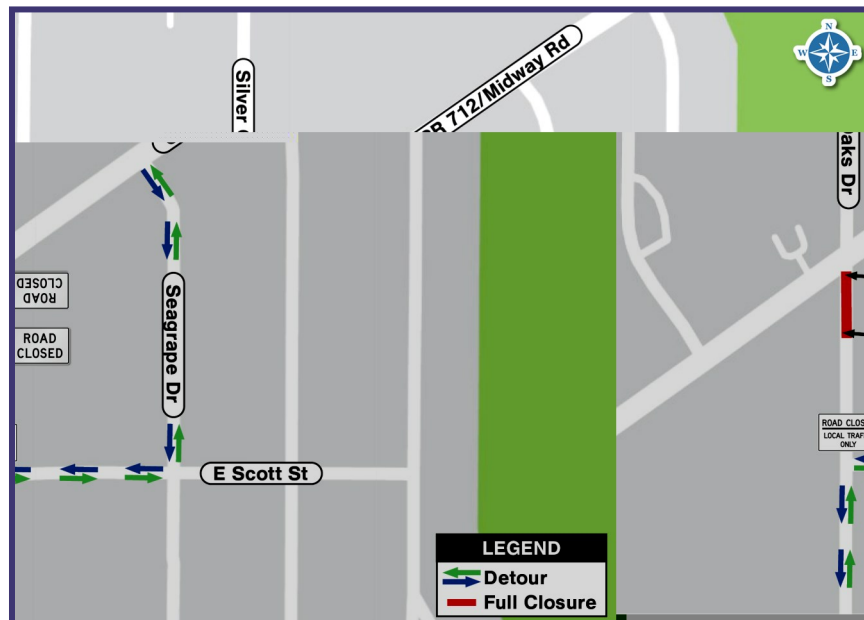

TRAFFIC DETOUR OF SILVER OAKS DRIVE AT COUNTY ROAD (CR) 712/MIDWAY ROAD EXTENDED THROUGH SEPT. 12

To ensure community and crew safety as we work to enhance the roadway and provide a safer and more resilient infrastructure, southbound Silver Oaks Drive at CR 712/Midway Road will be closed daily through 4 p.m. on Friday, Sept. 12, 2025, for drainage work. This closure was first implemented on Aug. 11. If weather or unforeseen circumstances arise, Silver Oaks Drive will reopen by Friday, September 19, 2025. Signage will be posted to assist motorists.

- Northbound Silver Oaks Drive to CR 712/Midway Road motorists will be detoured via east on East Scott Street, north on Seagrape Drive to CR 712/Midway Road.
- Southbound Silver Oaks Drive motorists from CR 712/Midway Road will be detoured via south on Seagrape Drive, west on east Scott Street to south on Silver Oaks Drive.
