This project aims to enhance visibility, safety, and the longevity of our communities infrastructure.

Construction Cost: \$688,162 Construction Start: March 2025 Estimated Completion: Late 2025

PROJECT IMPROVEMENTS

- Upgrading existing lighting systems with LED fixtures to enhance nighttime visibility and improve safety along the project corridors
- Installing new light poles to enhance nighttime visibility and improve safety along the project corridors

TRAFFIC IMPACTS

- Lane closures are permitted nightly within Palm Beach County, 7:00 p.m. until 6:00 a.m., as needed, Monday through Friday
- Lane closures are permitted daily within Broward County, 9:00 a.m. until 3:30 p.m., as needed, weekdays and weekends
- Lane closures are permitted nightly within Broward County, 9:00 p.m. until 5:30 a.m., as needed, Sunday through Thursday, and 11:00 p.m. until 7:00 a.m., as needed, Friday and Saturday
- Motorist and pedestrian access to businesses and residences will be maintained at all times
- Additional information about lane closures, detours, and pedestrian impacts will be provided in the weekly traffic report distributed by FDOT


