95 Express Lanes Phase 3C Project – New Traffic Pattern for Eastbound SR 862/I-595

State Road (SR) 9/I-95 from south of SR 820/Hollywood Boulevard to south of SR 842/Broward Boulevard and SR 862/I-595 from US 441/SR 7 to SR 9/I-95

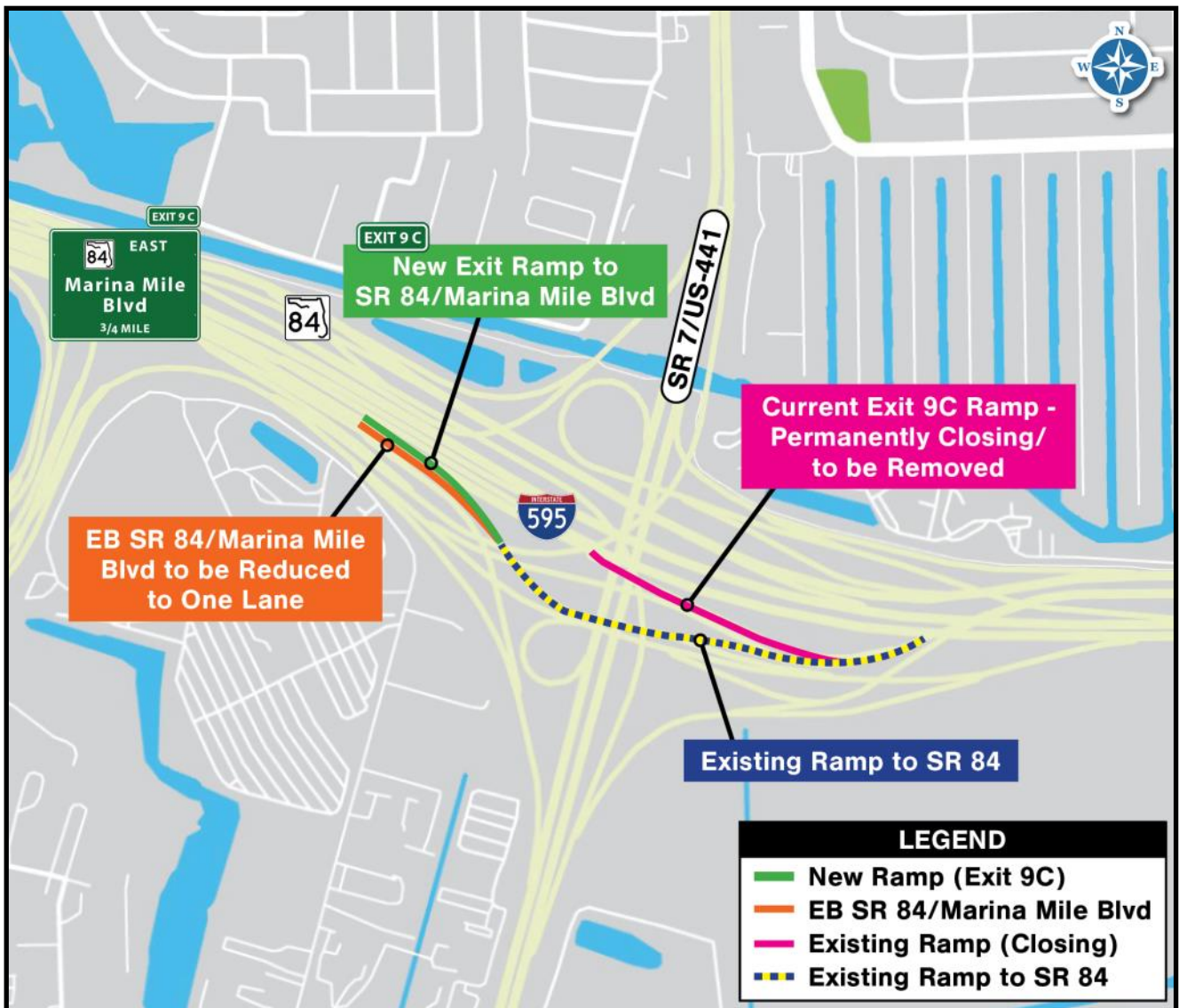

New Eastbound SR 862/I-595 Traffic Pattern and Exit Ramp to SR 84/Marina Mile Blvd (Exit 9C) To Begin Aug. 11

Beginning the week of Aug. 11, a new traffic pattern will be implemented along eastbound SR 862/I-595 as part of ongoing roadway improvements designed to enhance safety and reduce weaving movements along SR 862/I-595.

- **Permanent Ramp Closure and Relocation:** Beginning at 11 p.m. on Monday, Aug. 11, the existing eastbound SR 862/I-595 exit ramp to SR 84/Marina Mile Boulevard (Exit 9C) will be permanently closed and removed. The new ramp will be relocated to the west and will open on Aug. 12.
- **New Ramp Opening:** Beginning at 6 a.m. on Tuesday, Aug. 12, the newly constructed eastbound SR 862/I-595 exit ramp to SR 84/Marina Mile Boulevard (Exit 9C) will open approximately 500 feet west of the original exit ramp. This new one-lane exit ramp will serve as the permanent Exit 9C, providing direct access to SR 84/Marina Mile Boulevard.
- **Eastbound SR 862/I-595 Managed Lanes Egress Adjustment:** Beginning at 5 a.m. on Wednesday, Aug. 13, the egress from the eastbound SR 862/I-595 managed lanes will be reduced from two lanes to one, requiring drivers to merge into the general-purpose lanes through a single-lane exit.

Please note that all scheduled activities are subject to change due to weather or other unforeseen circumstances. Signage will be in place to guide motorists through the updated configuration.



These improvements support future corridor enhancements, including a new eastbound SR 862/I-595 entrance ramp from SR 91/Florida's Turnpike and new direct connector ramps linking SR 862/I-595 to the SR 9/I-95 managed lanes.
