

SNAKE ROAD ENTRANCE RAMP TO NORTHBOUND SR 93/I-75/ALLIGATOR ALLEY TO CLOSE WEEKENDS, JULY 11—27

The Snake Road entrance ramp to northbound SR 93/I-75/Alligator Alley will be closed as needed on weekends, 9 p.m. Friday through 11 a.m. Sunday, starting Friday, July 11 through Sunday, July 27 for guardrail installation and roadway paving operations. Traffic will be detoured via southbound SR 93/I-75/Alligator Alley and make a U-turn at the L-28 Canal Service Road to proceed along northbound SR 93/I-75/Alligator Alley. FHP will be onsite and detour signage will be in place to assist motorists.

In addition, construction activities will occur as needed on the southbound SR 93/I-75/Alligator Alley exit ramp to Snake Road. Construction activities at the Snake Road interchange will be restricted to one ramp at a time.
