From Southwest 51st Avenue to State Road (SR) 7/US 441 In the City of Plantation Broward County, FL Financial Project ID Numbers: 443948-1-52-01 and 443948-1-52-02

The Florida Department of Transportation (FDOT) is pleased to provide the community information regarding the Davie Boulevard Extension/Peters Road RRR Project from Southwest 51st Avenue to SR 7/US 441 in the City of Plantation. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities.

The City of Plantation, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested FDOT District Four design and construct the Davie Boulevard Extension/Peters Road RRR Project through the Plantation Resolution No. 443948-1. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County, and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. - Milling and resurfacing the existing roadway within the project limits to ensure long-term infrastructure resilience
- Constructing raised medians from Southwest 46th Avenue to SR 7/US 441
- Installing drainage from Southwest 46th Avenue to SR 7/US 441 to enhance long-term infrastructure resilience
- Upgrading existing pedestrian signals at signalized intersections to improve push button accessibility
- Upgrading curb ramps, pavement markings, and signage to improve visibility and accessibility

- Single lane closures and full closures along Davie Boulevard Extension/Peters Road will be implemented as needed for drainage operations
- Davie Boulevard Extension/Peters Road from Southwest 46th Avenue to SR 7/US 441 will be reduced to a single lane in each direction for median construction
- Business and residential access will be maintained at all times throughout construction
