The Florida Department of Transportation (FDOT) is pleased to provide the community with information regarding the Davie Boulevard Extension/Peters Road RRR Project from SW 51st Avenue to SR 7/US 441 in the City of Plantation and unincorporated Broward County. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

Broward County as the Project Sponsor, received funding as a project prioritized through the Broward Metropolitan Planning Organization (MPO) and requested FDOT District 4 design and construct the Davie Boulevard Extension/Peters Road RRR Project as memorialized in Broward County Resolution No. 2017-498. Construction Cost: \$2,565,294 Construction Start: April 2025 Estimated Completion: Early 2026

PROJECT IMPROVEMENTS

- Milling and resurfacing the existing roadway within the project limits to ensure long-term infrastructure resilience
- Constructing raised medians from SW 46th Avenue to SR 7/US 441
- Installing drainage from SW 46th Avenue to SR 7/US 441 to enhance long-term infrastructure resilience
- Upgrading existing pedestrian signals at signalized intersections to improve push button accessibility
- Upgrading curb ramps, pavement markings, and signage to improve visibility and accessibility



TRAFFIC IMPACTS

- Single lane closures along Davie Boulevard Extension/ Peters Road in each direction will be implemented as needed for drainage installation and median construction
- Full closure of westbound Davie Boulevard Extension/ Peters Road is permitted 9:00 p.m. through 7:00 a.m., Monday through Friday. Traffic will be detoured.
- Business and residential access will be maintained at all times throughout construction
