State Road (S.R.) 93/I-75 at Royal Palm Boulevard Interchange Improvements Project

From S.R. 818/Griffin Road to SW 14th Street

In the towns of Southwest Ranches and Davie, and the City of Weston Broward County, FL



Southbound S.R. 93/I-75 from Royal Palm Boulevard to S.R. 818/Griffin Road to close nightly Oct. 14 - 16

To ensure community and public safety, all general purpose lanes of southbound S.R. 93/I-75 from just north of Royal Palm Boulevard to S.R. 818/Griffin Road will be closed nightly, from 9 p.m. until 6 a.m., Tuesday, Oct. 14 through Thursday, Oct. 16 for overhead sign removal. In association with this work, the southbound S.R. 93/I-75 managed lane ingress just south of Royal Palm Boulevard will be closed. Motorist wishing to enter the managed lanes will be able to do so at the ingress just south of S.R. 818/Griffin Road. Southbound managed lane traffic will remain unchanged.

Traffic will be detoured via the S.R. 93/I-75 southbound exit ramp to Royal Palm Boulevard westbound, Weston Road southbound, and S.R. 818/Griffin Road eastbound to the S.R. 93/I-75 southbound entrance ramp. Florida Highway Patrol (FHP) will be onsite to assist motorists.
