### SR 93/I-75 AT ROYAL PALM BOULEVARD INTERCHANGE IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming SR 93/I-75 at Royal Palm Boulevard Interchange Improvements Project from SR 818/Griffin Road to SW 14<sup>th</sup> Street in the towns of Southwest Ranches and Davie, and the City of Weston. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

**Construction Cost:** \$36.2 Million

**Construction Start:** September 2025

**Estimated Completion:** Summer 2028

#### PROJECT IMPROVEMENTS

- Widening the SR 93/I-75 mainline to add an additional lane and enhance entry and exit movements
- Widening the SR 93/I-75 exit and entrance ramps at Royal Palm Boulevard and SR 818/Griffin Road to increase storage capacity and enhance traffic flow
- Widening the SR 93/I-75 bridge over the C-11 Canal to support the SR 93/I-75 mainline expansion and enhance traffic flow
- Installing Wrong-Way Driver Detection Systems at key locations to enhance safety:
  - Southbound SR 93/I-75 exit ramp to westbound Royal Palm Boulevard
  - Northbound SR 93/I-75 exit ramp to westbound Royal Palm Boulevard
  - Northbound SR 93/I-75 exit ramp to westbound SR 818/Griffin Road
- Milling and resurfacing the roadway within the project limits to ensure long-term infrastructure resilience
- Upgrading signing and pavement markings within the project limits to enhance nighttime visibility
- Upgrading existing light poles with new LED fixtures and installing additional poles throughout the project limits to enhance nighttime visibility

#### TRAFFIC IMPACTS

- Lane closures on SR 93/I-75 mainline and ramps are permitted nightly as needed, 9:00 p.m. until 6:00 a.m., Sunday through Thursday
- Lane closures on Royal Palm Boulevard are permitted nightly as needed, 9:00 p.m. until 6:00 a.m., Sunday through Thursday
- Full closures of SR 93/I-75 mainline and ramps with detours are permitted nightly as needed, for paving and overhead sign structure operations, 10:00 p.m. until 5:00 a.m., Sunday through Thursday
- Shoulder closures are permitted as needed

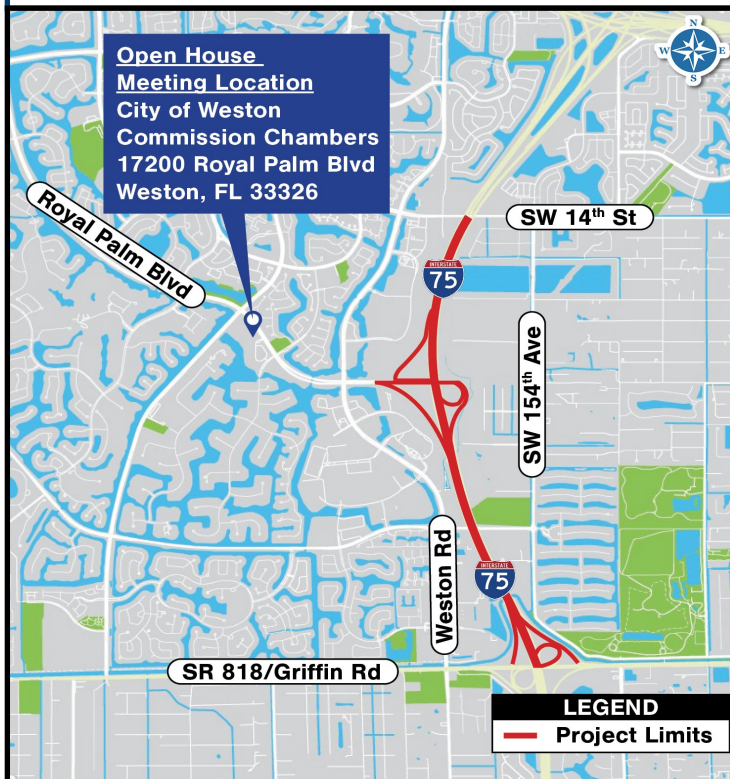
