S.R. 84 AT WESTON ROAD INTERSECTION IMPROVEMENTS

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming S.R. 84 and Weston Road Improvements Project in the City of Sunrise. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

Construction Cost: \$3,189,221

Construction Start: November 2025

Estimated Completion: Fall 2026

PROJECT IMPROVEMENTS

- Widening westbound S.R. 84 to accommodate a second left turn lane to southbound Weston Road to improve intersection operations and capacity.
- Widening southbound Weston Road between westbound and eastbound S.R. 84 to provide an additional through lane to improve capacity.
- Upgrading signalization at the intersections of westbound and eastbound S.R. 84 along Weston Road to complement roadway improvements.
- Upgrading existing street light poles with LED fixtures throughout the project corridor to enhance nighttime visibility and pedestrian safety.
- Upgrading sidewalks, curb ramps, pavement markings, and signage to improve visibility and accessibility.

TRAFFIC IMPACTS

- Lane closures along Weston Road are permitted, as needed, 9:00 p.m. until 7:00 a.m.
- Left turn lane from northbound Weston Road to westbound S.R. 84 will be closed for median demolition. Vehicles will be able to perform the left turn movement from the remaining lane.
- The U-turn movement from westbound S.R. 84 to eastbound S.R. 84 will be closed throughout construction.
- Motorists and pedestrian access to businesses and residences will be maintained at all times.
