### Northbound NW 7<sup>th</sup> Avenue at S.R. 838/Sunrise Boulevard to close nightly as needed, Jan. 11-22

Northbound NW 7<sup>th</sup> Avenue at S.R. 838/Sunrise Boulevard will be closed to traffic, nightly as needed, 9 p.m. until 7 a.m., Sunday through Thursday, beginning Sunday, Jan., 11, 2026 through Thursday, Jan. 22, 2026, for drainage and roadway reconstruction work. NW 7<sup>th</sup> Avenue traffic will be detoured via westbound S.R. 838/Sunrise Boulevard, northbound S.R. 845/Powerline Road, eastbound 13<sup>th</sup> Street, and northbound NW 7<sup>th</sup> Avenue. Signage will be in place to assist motorists.
