State Road (SR) 7/US 441 Corridor Improvements Project (Group 9)

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the upcoming SR 7/US 441 Transit Corridor Improvements Project (Group 9) along SW 45th Street/Orange Drive from Florida's Turnpike to SR 7/US 441; and Taft Street from SR 7/US 441 to N 40th Street, in the Town of Davie and the City of Hollywood.

The Town of Davie and City of Hollywood, as the Project Sponsors, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT District Four design and construct the SR 7/US 441 Transit Corridor Improvement projects along SW 45th Street/Orange Drive from Florida's Turnpike to SR 7/US 441 through the Town of Davie Resolution No. 2019-135 and along Taft Street from SR 7/US 441 to N 40th Street through the City of Hollywood Resolution No. 2021-280. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. PROJECT IMPROVEMENTS

SW 45th Street/Orange Drive from Florida's Turnpike to SR 7/US 441

- Upgrading existing drainage structures to improve long-term resilience and longevity of critical infrastructure
- Adding a continuous concrete sidewalk along the north side of SW 45th Street/Orange Drive to enhance pedestrian mobility
- Upgrading curb ramps, pavement markings, and signage to improve visibility and accessibility

Taft Street from SR 7/US 441 to N 40th Avenue

- Milling and resurfacing the existing roadway within the project limits to ensure long-term resilience
- Upgrading existing drainage structures to improve long-term resilience and longevity of critical infrastructure
- Adding an 8-foot to 11-foot shared-use path along the north side of Taft Street to enhance pedestrian mobility
- Upgrading curb ramps, pavement markings, and signage to improve visibility and accessibility

TRAFFIC IMPACTS

- Lane closures along SW 45th Street/Orange Drive and Taft Street are permitted 9:00 a.m. until 4:00 p.m., Monday through Saturday
- Motorist and pedestrian access to businesses and residences will be maintained at all times
