Daily Full Closures along Northbound North 56th Ave., from North Hills Dr. to Stirling Rd.

Northbound North 56th Avenue from North Hills Drive to Stirling Road will be closed daily, Monday through Friday, between 9 a.m. to 1:30 p.m. for roadway widening to accommodate 7-foot buffered bicycle lanes. Traffic will be detoured through North Hills Drive and Sarazen Drive. Access will be maintained for school drop-off and pick-up, local residents, public transportation and emergency responders.

This work is a part of the Southwest Broward Mobility Improvements Project, and is being done in partnership with the Broward MPO. Project improvements include widening the roadway to accommodate 7-foot buffered bicycle lanes and adding sidewalks to create a continuous facility in each direction of SW 56th Avenue; adding shared lane pavement markings in each direction along SW 62nd Avenue and North 64th Avenue to enhance the safe travel of bicycles and motor vehicles in the same traffic lane; and adding sidewalks to create a continuous facility in each direction of SW 62nd Avenue.
