## NW 29<sup>th</sup> STREET MOBILITY IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the mobility improvements along NW 29<sup>th</sup> Street in the City of Wilton Manors.

The City of Wilton Manors, as the project sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT design and construct the NW 29<sup>th</sup> Street Mobility Improvements Project through the City of Wilton Manors Resolution No. 2015-117. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. ### PROJECT IMPROVEMENTS

- Widening the roadway to accommodate 4-foot bicycle lanes in each direction
- Constructing new sidewalks along the south side of the corridor
- Upgrading pedestrian crosswalks to countdown timers at N. Andrews Avenue
- Milling and resurfacing the roadway within the project limits
- Replacing the decorative stamped concrete at the intersections of NW 7<sup>th</sup> Avenue, NW 6<sup>th</sup> Avenue, and NW 3<sup>rd</sup> Avenue

### TRAFFIC IMPACTS

- Single lane closures are permitted, Monday through Friday, between 8:00 a.m. and 7:00 p.m.
- Pedestrian detours may occur between 8:30 a.m. to 3:00 p.m., Monday through Friday, when school is in session.
- Business, pedestrian, and residential access will be maintained at all times.

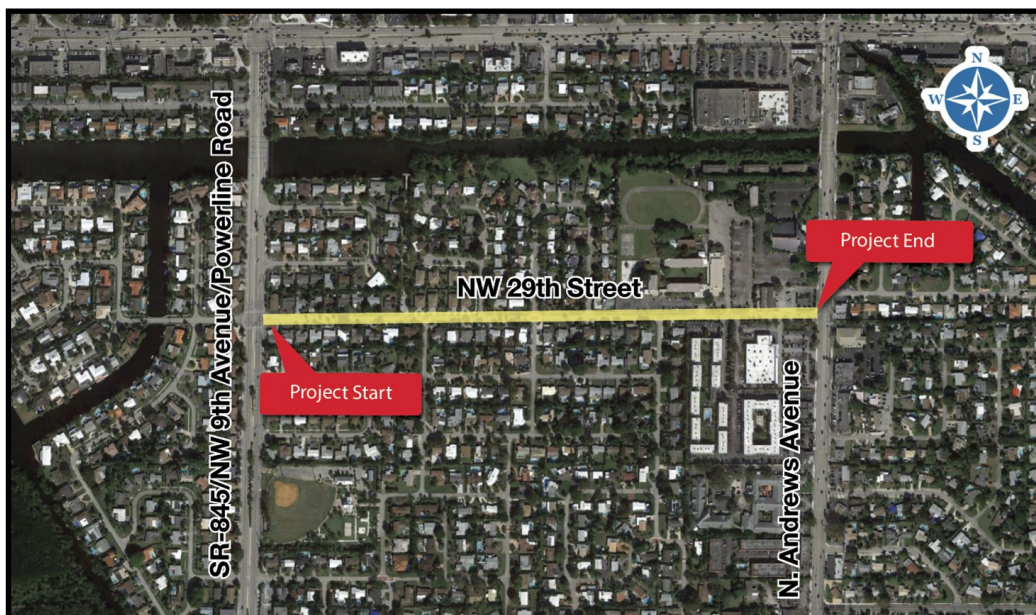
