NW 31<sup>st</sup> Avenue Mobility Improvement Project is a part of a U.S. Department of Transportation – Transportation Investment Generating Economic Recovery (TIGER) Grant, awarded to the Broward MPO and its local partners to enhance continuity and extend the Broward Regional Complete Street network. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. 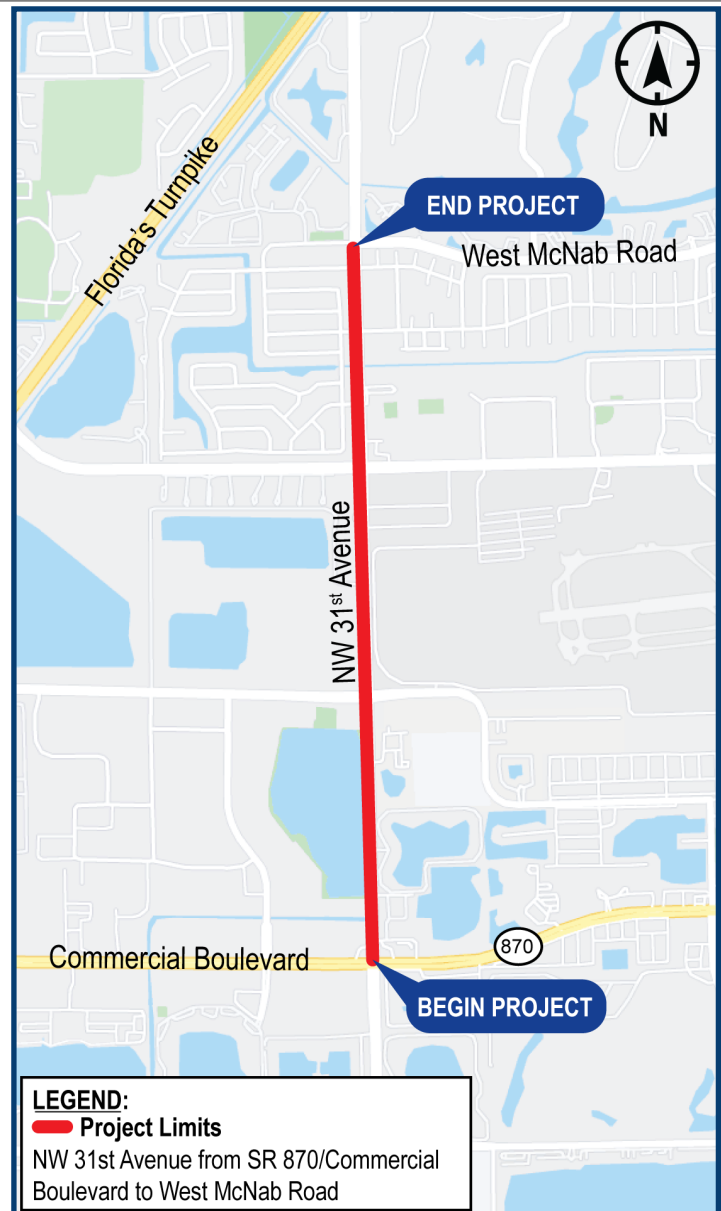
**Construction Cost: \$3.5 million    Construction Start Date: June 1, 2021    Anticipated Completion: Summer 2022**

### PROJECT IMPROVEMENTS

- Repurposing the outside travel lanes from Commercial Boulevard to NW 62<sup>nd</sup> Street to accommodate 5-foot bicycle lanes
- Widening the roadway and median from NW 62<sup>nd</sup> Street to West McNab Road to accommodate 4-foot bicycle lanes
- Installing traffic signal mast arms and pedestrian signalization at West Prospect Road, NW 65<sup>th</sup> Drive, and West McNab Road
- Milling, resurfacing, and adding pavement markings

### TRAFFIC IMPACTS

- Lane closures may occur 9:00 a.m. to 3:30 p.m., Sunday through Saturday
- Business signage will be provided to identify driveways
- Access to businesses and residents will be maintained at all times
