## POWERLINE ROAD MOBILITY IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT), District Four, will host a Virtual Public Meeting regarding mobility improvements on SR 845/Powerline Road from SR 870/Commercial Boulevard to NW 29th Street in the City of Oakland Park. The meeting will begin at 5:00 p.m. and include a brief presentation followed by questions and comments from the public.

Powerline Road is a part of a U.S. Department of Transportation – Transportation Investment Generating Economic Recovery (TIGER) Grant, awarded to the Broward MPO and its local city partners to enhance continuity and extend the Broward Regional Complete Street network. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. ## PROJECT IMPROVEMENTS

- Repurposing the existing outside travel lanes from Commercial Boulevard to West Oakland Park Boulevard to accommodate 7-foot buffered bicycle lanes and 4-foot raised landscaped islands in each direction
- Repurposing the outside lanes from West Oakland Park Boulevard to NW 29th Street to accommodate 4-foot bicycle lanes
- Milling and resurfacing of the corridor
- Installing landscaping and irrigation

## TRAFFIC IMPACTS

- Lane closures may occur from 9:00 a.m. to 3:30 p.m., Sunday through Saturday.
- Lane closures will not be permitted within school zones from 7:00 a.m. to 9:00 a.m. and 2:00 p.m. to 5:00 p.m., Monday through Friday.
- Access to emergency services, businesses and residents will be maintained at all times.

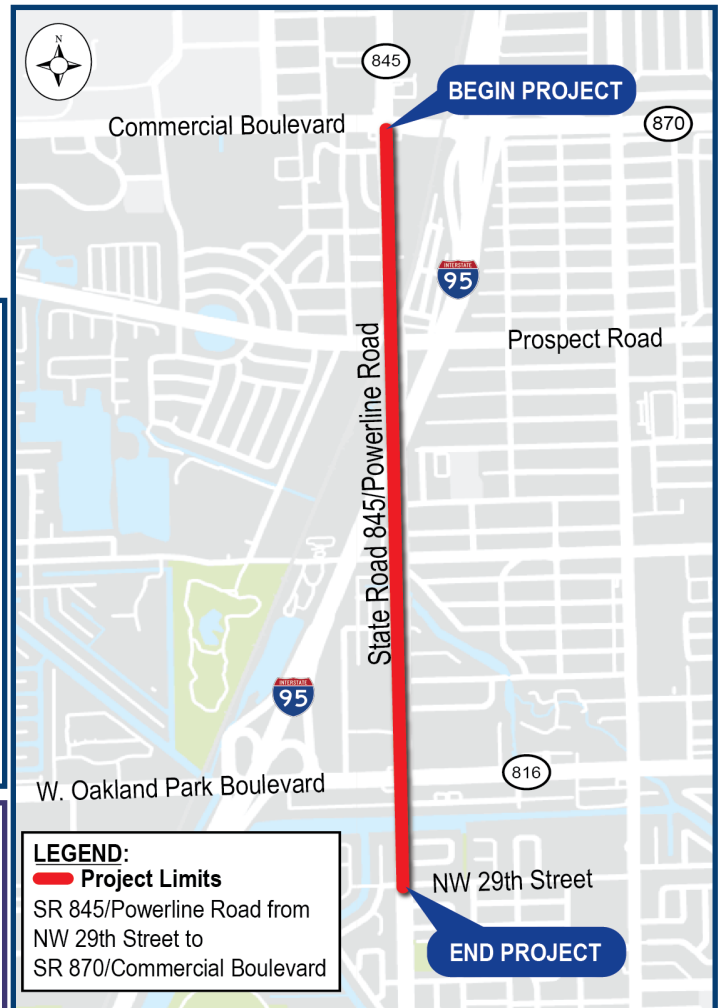
