## ROADWAY IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT), District Four, will conduct a Virtual Public Meeting regarding the proposed improvements along Bayview Drive from SR 838/Sunrise Boulevard to SR 870/Commercial Boulevard. This Virtual Public Meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting through the registration link or by e-mailing the Project Manager. The presentation will start at 6:00 p.m., followed by a question and answer session. #### **PROPOSED IMPROVEMENTS**

- Construct sidewalks along Bayview Drive at isolated locations where impacts to landscaping and other privacy features are minimal.
- Add bike lanes between NE 26 Street and NE 25 Place.
- Minor drainage modifications to locations impacted by the proposed improvements.
- Install pedestrian midblock crossings at:
  - South of NE 15 Street
  - South of NE 45 Street
- Construct raised intersections along Bayview Drive at:
  - NE 14 Street
  - NE 18 Street
  - NE 27 Street
  - NE 43 Street
- Construct roundabouts at:
  - NE 37 Drive
  - NE 47 Street
- Addition of a median separator and modifications to the intersection of NE 28 Avenue.
- Reduce pedestrian crossing distance at NE 13 Court.

#### **CONSTRUCTION IMPACTS**

- All work will be done in phases to reduce the impact of construction to the community.
- All lane closures will occur during non-peak hours.
- No full roadway closures will occur.
- Access to private properties will be maintained at all times during construction.

#### **CONSTRUCTION INFORMATION**

- Construction Start Date: Spring 2022
- Anticipated Completion: Fall 2023
- Construction Cost Estimate: \$1.5 Million


