

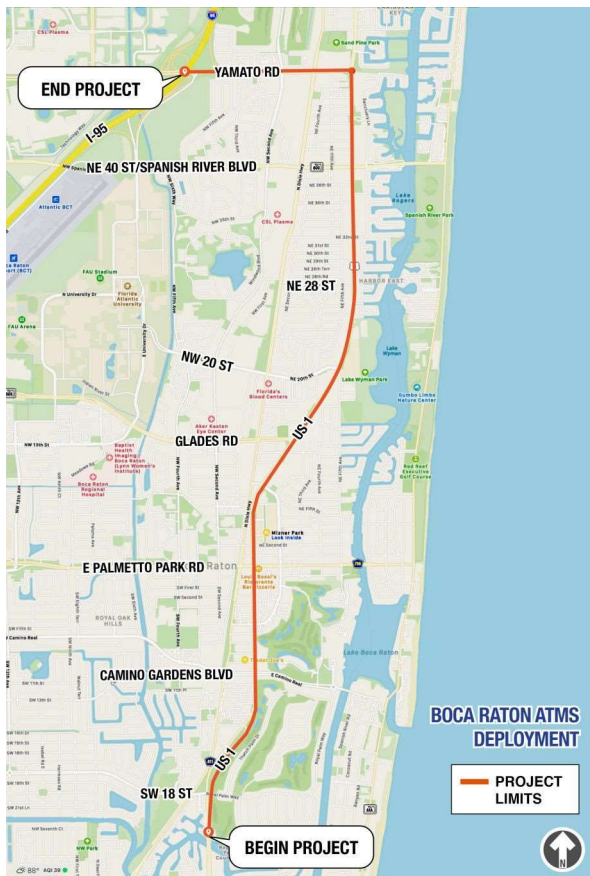

PROJECT IMPROVEMENTS

- Using technology, such as vehicle detection and communication devices, to actively manage traffic and increase transportation system efficiency
- Fiber optic cable (approximately 5.9 miles)
- Bluetooth devices at intersection locations
- Closed Circuit TV (CCTV) cameras
- Traffic Signal System detection upgrades at existing signalized intersections to include pedestrian/bicycle detection

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the impacts on the community
- Temporary off-peak lane closures will be necessary
- Access to adjacent properties will be maintained at all times

CONSTRUCTION INFORMATION

- Construction Start Date: Spring 2023
- Anticipated Completion: Summer 2024
- Construction Cost Estimate: \$2.9 million
