

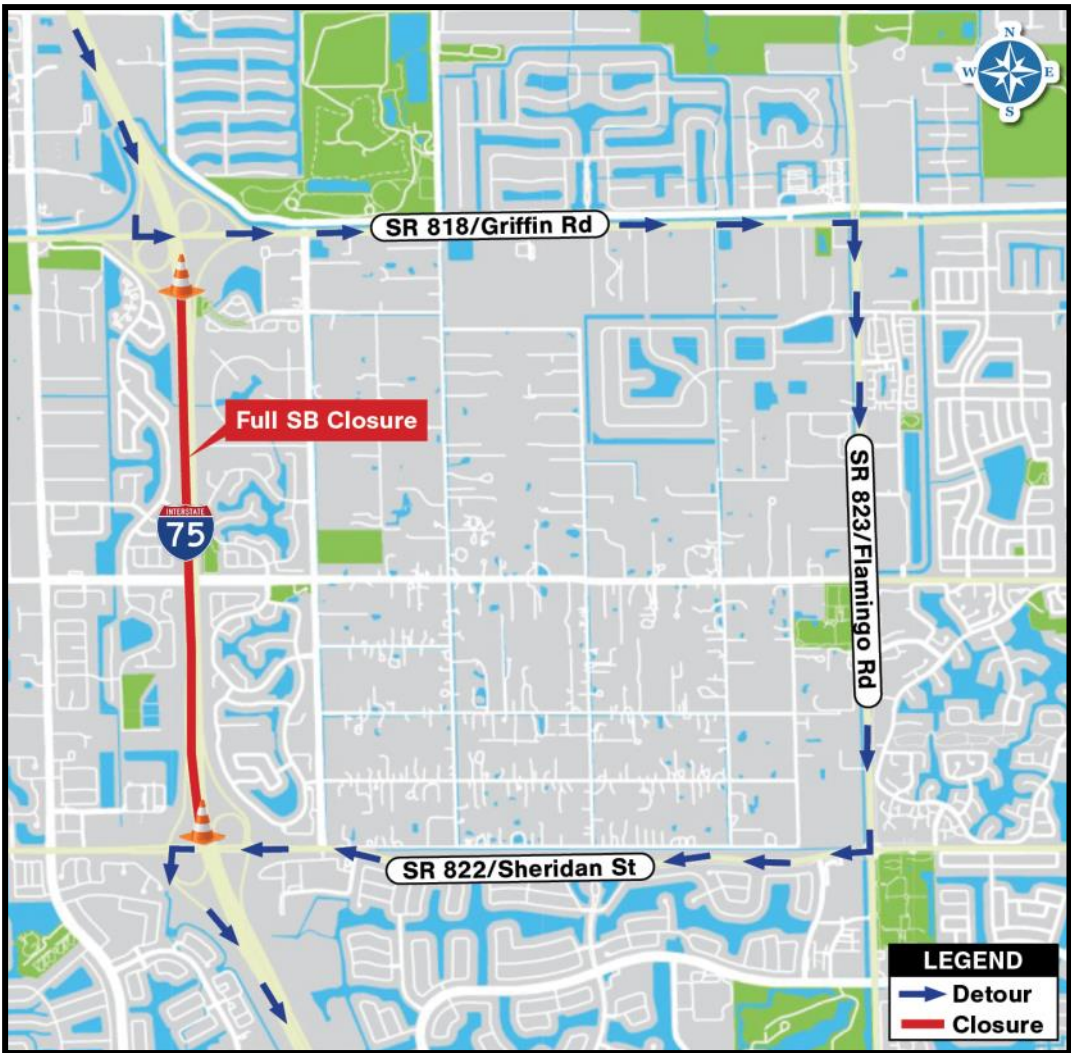

**SR 93/I-75 Improvements Project from SR 822/Sheridan Street to SR 818/Griffin Road**

**SR 93/I-75 SOUTHBOUND BETWEEN SR 818/GRIFFIN ROAD AND SR 822/SHERIDAN STREET TO CLOSE APRIL 1 & 7**

All lanes of SR 93/I-75 southbound between SR 818/Griffin Road and SR 822/Sheridan Street will be closed to traffic, 10 p.m. until 6 a.m., Monday night, April 1 and Sunday night, April 7 for overhead sign structure installation. Traffic will be detoured via the SR 93/I-75 southbound exit ramp to SR 818/Griffin Road eastbound, Flamingo Road southbound, and SR 822/Sheridan Street westbound to the SR 93/I-75 southbound entrance ramp. The SR 93/I-75 southbound express lane ingresses from the westbound SR 862/I-595 express lanes and from south of Royal Palm will also be closed. Motorists may re-enter the express lanes just south of SR 822/Sheridan Street. FHP will be onsite to assist motorists. Tuesday, April 2 and Monday, April 8 will be used as a contingency as needed.



Improvements as part of this project include roadway widening to provide continuous auxiliary lanes and 10-foot shoulders in each direction of SR 93/I-75, repaving and restriping the existing asphalt, replacing overhead signage, installing new guardrail in each direction of SR 93/I-75, and updating drainage, lighting, and Intelligent Transportation Systems (ITS).
