## SR 822/SHERIDAN STREET AT N. 46TH AVENUE INTERSECTION IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the upcoming roadway improvements at the SR 822/Sheridan Street and N. 46th Avenue Intersection within the city of Hollywood.

**Construction Cost:** \$1,746,922

**Construction Start Date:** September 2023

**Anticipated Completion:** Summer 2024

### PROJECT IMPROVEMENTS

- Upgrading existing signalization with mast arms
- Extending the left-turn lanes at the intersection to provide additional vehicle storage capacity
- Milling and resurfacing the existing roadway
- Replacing and upgrading existing concrete sidewalk ramps
- Upgrading signing, pavement markings, lighting with LED fixtures, and pedestrian signals

### TRAFFIC IMPACTS

- Single lane closures are permitted along SR 822/ Sheridan Street between 9:00 a.m. and 4:00 p.m. and between 10:00 p.m. and 6:00 a.m.
- Single lane closures are permitted along N. 46th Avenue between 9:00 a.m. and 4:00 p.m.
