#### PROPOSED IMPROVEMENTS

- Upgrading the existing lighting system to meet current standards
- Removing existing light poles
- Installing new light poles
- Adjust impacted guardrails

#### MAINTENANCE OF TRAFFIC

- Daytime temporary lane closures during non-peak hours will occur
- All work will be done in phases to reduce the impacts of construction to the community
- No full roadway closures or detours will occur
- Access to businesses and residential properties will be maintained at all times during construction

- Construction Cost Estimate: **\$ 607,107.00**

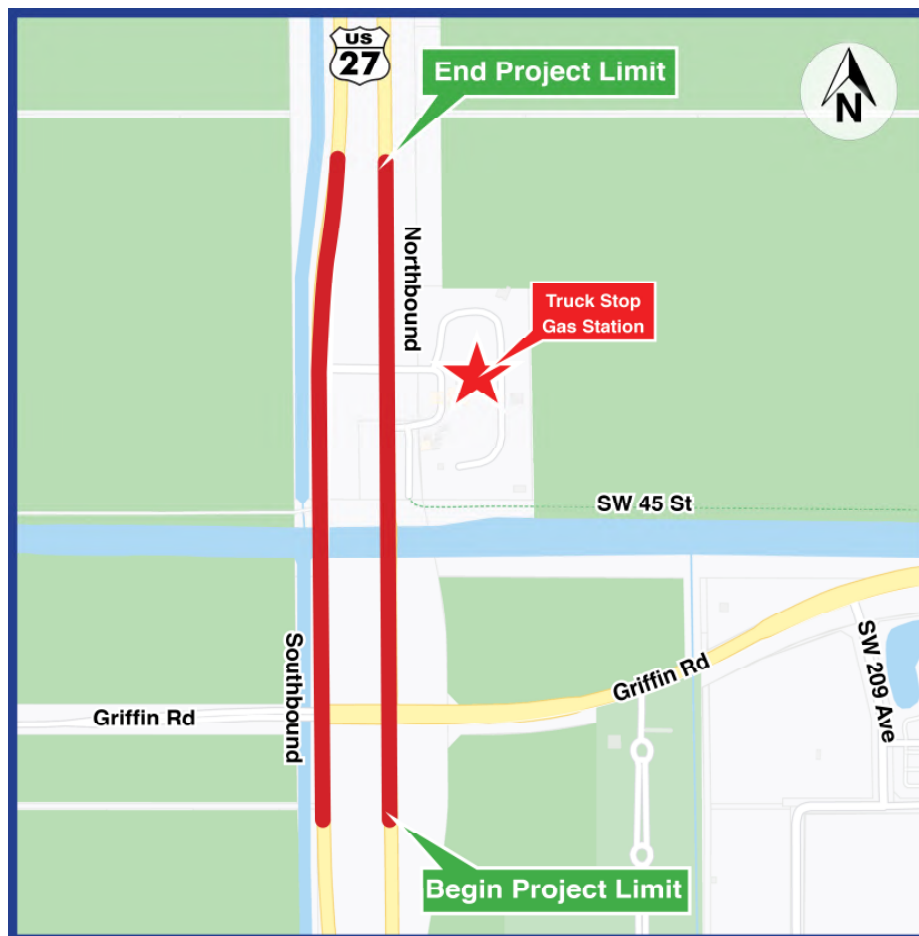
