HAMMONDVILLE ROAD MOBILITY IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information about mobility improvements along Hammondville Road/Dr. Martin Luther King Jr. Boulevard in the City of Pompano Beach.

The Hammondville Road Mobility Improvement Project is a part of a U.S. Department of Transportation – Transportation Investment Generating Economic Recovery (TIGER) Grant, awarded to the Broward MPO and its local city partners to enhance continuity and extend the Broward Regional Complete Street network. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. Construction Cost: \$3 Million Construction Start Date: June 1, 2021 Anticipated Completion: Summer 2022

PROJECT IMPROVEMENTS

- Widening the inside travel lanes and reducing the median to accommodate 7-foot buffered bicycle lanes in each direction
- Upgrading pedestrian signalization at the mid-block crossing east of NW 18th Drive with pedestrian detectors
- Installing and upgrading pedestrian lighting in each direction
- Installing landscaping and irrigation in the median
- Upgrading signage and pavement markings
- Milling and resurfacing the roadway

TRAFFIC IMPACTS

- Lane closures may occur from 9:00 a.m. to 3:30 p.m., Sunday through Saturday
- All left turns will be maintained during construction
- Access to businesses and residential areas will be maintained at all times
