





Complete Streets and Other Localized Initiatives Program




- Broward MPO competitive grant program that provides funding opportunities for small local transportation projects which improve the safety and mobility for all transportation users in Broward County.
- The program can fund projects such as (but not limited to): complete streets projects, traffic calming and intersection improvements, ADA upgrades, mobility hubs, bus shelters, bike racks and technology advancements such as transit signal priority and traffic control devices
- Applicants are required to submit “program ready” projects with proof of roadway ownership, well defined scope of work, partner collaboration, cost estimate, documentation of public outreach and resolution of support.
- The following projects were submitted by the City of Hollywood (2016) and awarded funding:
 - **US-1 from Johnson St. to Sheridan St. (FM No. 439991-1)**
 - **US-1 from Pembroke Rd. to Johnson St. (FM No. 441582-1)**




Project Overview

Project Length: 2.62 miles

Proposed Improvements:


- Provide 4' bicycle lanes by resurfacing roadway
- Replace existing lighting with LED fixtures
- Install new pedestrian LED light posts
- Improve lighting at signalized intersections to meet safety requirements including intersections at Harrison Street and Tyler Street
- Install new stamped asphalt crosswalks in all approaches at signalized intersections
- Install concrete pavers on sidewalks from Monroe Street to Young Circle and from Young Circle to Fillmore Street
- Replace sidewalk sections damaged by trees and prune roots as needed.
- Install tree grates
- Replace pedestrian ramps that do not comply with ADA
- Upgrade signing and pavement markings
- Upgrade pedestrian signals

Proposed Roadway Typical Section



Installation of 4' Bicycle Lanes

- Provide 4' bicycle lane along both directions
- Green-colored pavement to increase driver awareness at conflict locations



Lighting & Signalization Improvements



- Replacement of existing luminaires along the corridor with LED lights
- Lighting retrofits at existing signalized intersections to improve visibility
- New pedestrian light poles along both sidewalks

- Replacement of pedestrian push-buttons and signal heads to meet ADA

Temporary Traffic Control Plan

Temporary Traffic Control Plan

- Work will be completed in phases to minimize construction impacts
- Single lane closures will be required during construction along US - 1 and some of the side streets
- No full roadway closures will be required
- Lane closures will occur during off peak traffic times
- Access to properties adjacent to the corridor will be maintained throughout construction

Project Schedule and Cost

Project Schedule and Cost

Plans Production:

90% Plans: August 2021

100% Plans: October 2021

Letting: February 2022

Estimated Construction Start: Summer 2022

Estimated Completion: Winter 2023


Estimated Construction Cost: \$7.7 Million




