### OAKLAND PARK SIDEWALK IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT), District Four, will host a Virtual Public Meeting from 5 p.m. until 6 p.m. and In-Person Construction Open House from 6 p.m. until 7 p.m. regarding the sidewalk improvements within the neighborhoods of Central Oakland Park and Harlem McBride in the City of Oakland Park on Thursday, June 2, 2022. Please see detailed meeting information below. Representatives will be available to provide information and answer questions. Project documents will be available at the meeting and available for download from the virtual meeting platform.

The City of Oakland Park, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT District Four design and construct the Oakland Park Sidewalk Improvement Project through the City of Oakland Park Resolution R-2016-007. The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward County. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. ### PROJECT IMPROVEMENTS

- Constructing new sidewalks along:
  - NE 2nd Avenue from NE 34th Court to NE 35th Court
  - NE 3rd Avenue from north of NE 32nd Street to NE 36th Street
  - NE 6th Avenue from NE 32nd Street to NE 36th Street
  - NE 8th Avenue from north of Oakland Park Boulevard to NE 37th Street
  - NE 10th Avenue from north of Oakland Park Boulevard to NE 37th Street
  - NE 11th Avenue from NE 32nd Street to NE 38th Street
  - NE 32nd Street from NE 3rd Avenue to N Dixie Highway
  - NE 33rd Street from NE 3rd Avenue to N Dixie Highway
  - NE 34th Street from west of NE 3rd Avenue to NE 11th Avenue
  - NE 35th Street from NE 2nd Avenue to NE 3rd Avenue
  - NE 36th Street from west of NE 6th Avenue to NE 11th Avenue
  - NE 37th Street from NE 6th Avenue to NE 11th Avenue
  - NE 35th Court from NE 2nd Avenue to NE 5th Avenue
- Relocating and installing signage
- Relocating drainage structures
- Regrade swales to ensure proper drainage flow
- Modifying irrigation systems where impacted by the new sidewalk construction

### TRAFFIC IMPACTS

- Lane closures are permitted daily, 8 a.m. until 4 p.m.
- Business and residential access will be maintained at all times.
