HOLMBERG ROAD MOBILITY IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information regarding the mobility improvements project along Homberg Road in the City of Parkland.

The City of Parkland, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT District Four design and construct the Holmberg Road Mobility Improvement Project through the City of Parkland Resolution 2015-136. The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward County. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. Construction Cost: \$609,561

Construction Start Date: June 20, 2022

Anticipated Completion: Late 2022

PROJECT IMPROVEMENTS

- Widening the roadway at the entrance of Marjory Stoneman Douglas High School to accommodate a dedicated right-turn lane
- Milling and resurfacing within the project limits
- Restriping the roadway to accommodate bicycle lanes within the project limits
- Upgrading sidewalk and curb ramps
- Upgrading pedestrian signals, pavement markings, and signing

TRAFFIC IMPACTS

- One direction of Holmberg Road will be closed during paving operations. Traffic will be detoured using Pine Island Road, Trails End, and Nob Hill Road.
- Detours will not occur on weekdays when schools are in session, excluding summer school.
- Pedestrian detours may take place from Monday through Friday from 4:00 p.m. to 7:00 a.m. when schools are in session, excluding summer school.
- Access to Westglades Middle School and Marjory Stoneman Douglas High School will be maintained at all times.
