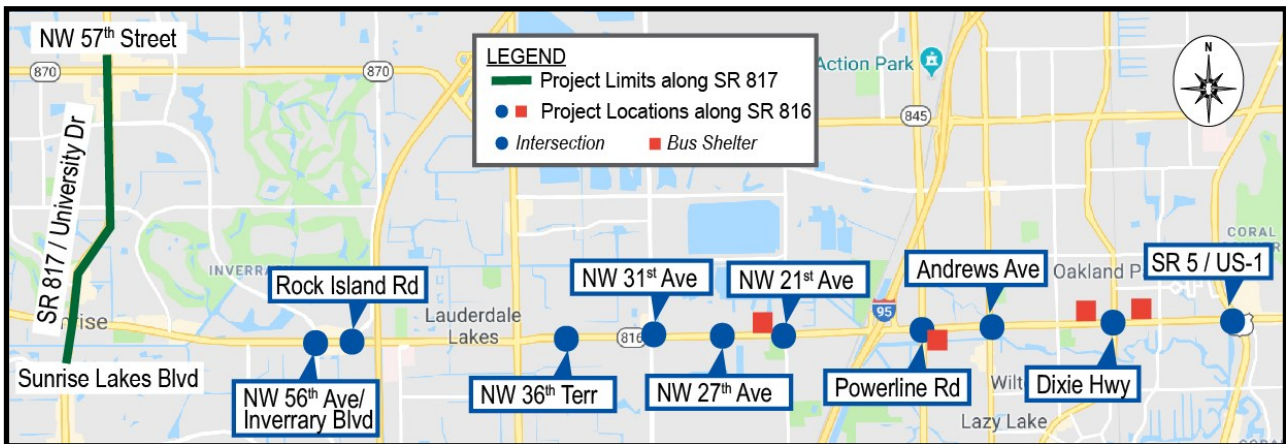
## UNIVERSITY DRIVE-OAKLAND PARK BOULEVARD IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT), District Four, will be implementing mobility improvements along SR 817/University Drive from north of NW 57th Street to Sunrise Lakes Boulevard and along SR 816/Oakland Park Boulevard from SR 817/University Drive to SR 5/US 1.

### PROJECT IMPROVEMENTS

**University Drive:** The mobility improvements along University Drive will include widening, resurfacing and restriping of the roadway to accommodate bike lanes. Sidewalks and pedestrian lighting will be installed on both sides of the roadway. The University Drive bridge over the C-13 Canal will be widened to accommodate 4-foot bicycle lanes. There will be enhancements to signalization, signage, drainage and pavement markings along the University Drive corridor.

**Oakland Park Boulevard:** Four new bus shelters will be installed, and traffic signal priority (TSP) will be added at 10 intersections. TSP facilitates the movement of transit vehicles through signalized intersections to improve schedule. This is accomplished through green time extension (or early return to green) to accommodate transit vehicles.
