### SR-9/I-95 AT SR-834/SAMPLE ROAD INTERCHANGE IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information about the SR-9/I-95 and SR-834/Sample Road Interchange Improvements Project in the cities of Deerfield Beach and Pompano Beach.

**Construction Cost:** \$31 million

**Construction Start:** January 2023

**Estimated Completion:** Early 2025

#### PROJECT IMPROVEMENTS

- Constructing dedicated merge lanes for I-95 northbound and southbound traffic from SR-834/Sample Road that are physically separated from the I-95 general purpose lanes
- Constructing noise walls
- Installing signalization mast arms on SR-834/Sample Road at the I-95 northbound and southbound off ramps and at the NE 3rd Avenue intersection
- Updating the lighting and the Intelligent Transportation System (ITS) at the I-95 and SR-834/Sample Road interchange
- Roadway and bridge widening, milling and resurfacing, signing and pavement markings
- Widening and milling and resurfacing on NE 3rd Avenue from south of NE 35th Court to south of NE 38th Street

#### I-95 TRAFFIC IMPACTS

- Lane closures on I-95 are permitted nightly, 10:30 p.m. to 5:30 a.m. Sunday through Thursday.
- Lane closures of I-95 ramps are permitted nightly, 10 p.m. to 5 a.m., Sunday through Thursday.
- Full closures of I-95 ramps are permitted nightly, 12 a.m. to 5 a.m., Sunday through Thursday.

#### TRAFFIC IMPACTS

- Lane closures on SR-834/Sample Road may occur from 9 a.m. to 3 p.m. and from 10 p.m. to 6 a.m., Monday through Friday.
- Lane closures on SR-834/Sample Road may occur from 7 a.m. to 6 p.m. on the weekends, and from 10 p.m. to 6 a.m. on Sunday.
- Full closures on SR-834/Sample Road are permitted nightly, 11 p.m. to 5 a.m., Sunday through Friday.
- Lane closures on NE 3rd Avenue are permitted daily and nightly, as needed.
- Access to businesses and residential properties will be maintained at all times during construction.
