POMPANO BEACH SIDEWALK IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT) District Four is pleased to provide information about sidewalk improvements and railroad safety along NE 6th Street and SW 6th Street in the city of Pompano Beach.

The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. The Broward MPO is a federally-mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward. PROJECT IMPROVEMENTS

- Constructing sidewalks to eliminate existing gaps along the roadway
- Constructing railroad crossing improvements where new sidewalks will be constructed
- Installing high emphasis pavement markings to enhance safety at the railroad crossings for drivers and pedestrians
- All improvements will meet Americans with Disabilities Act (ADA) requirements.

TRAFFIC IMPACTS

- Temporary lane closures may occur during non-peak hours.
- Pedestrian detours will be in place during sidewalk closures.
- Railroad crossings will be monitored by flagmen to ensure safety during construction at the crossings.
- Access to residences and businesses will be maintained at all times.
