### PROPOSED IMPROVEMENTS

- Resurface and restripe roadway pavement
- Upgrade and expand existing corridor lighting to LED luminaires
- Upgrade pedestrian lighting at signalized intersection crosswalks
- Upgrade curb ramps to meet standards
- Provide new signs and pavement markings
- Minor drainage improvements

### **MAINTENANCE OF TRAFFIC**

- Work will be done in phases to reduce the effects of construction on the community
- Temporary lane closures during non-peak hours on non-event days
- Access to businesses and residences will be maintained at all times
