SR 842/Broward Boulevard Intersection Improvements Project

The Florida Department of Transportation (FDOT), District Four, will host a Virtual Public Meeting for the roadway and intersection improvements project on SR 842/Broward Boulevard from NW/SW 7th Avenue/ Avenue of the Arts to SR 5/US-1/N Federal Highway, in the City of Fort Lauderdale.

Construction Cost: \$1,153,286

Construction Start: January 5, 2021

Estimated Completion: Summer 2021

PROJECT IMPROVEMENTS

- Replacing the existing brick pavers with asphalt and upgrading signing and pavement markings at the following intersections:
 - NW/SW 7th Avenue/Avenue of the Arts
 - N/S Andrews Avenue
 - NE/SE 3rd Avenue
 - SR 5/US-1/N Federal Highway
- Upgrading roadway lighting at the following intersections:
 - NW/SW 7th Avenue/Avenue of the Arts
 - NW/SW 5th Avenue
 - NW/SW 1st Avenue
 - N/S Andrews Avenue
 - NE/SE 3rd Avenue

TRAFFIC IMPACTS

- Single lane closures will occur along Broward Boulevard, Monday through Thursday from 9:30 p.m. to 6:00 a.m. for lighting improvements
- Multiple lanes closures will occur along Broward Boulevard, Friday through Monday from 9:30 p.m. to 6:00 a.m. for roadway improvements
- Intermittent full closures can be expected; advanced notice to the public will be provided along with the detour routes

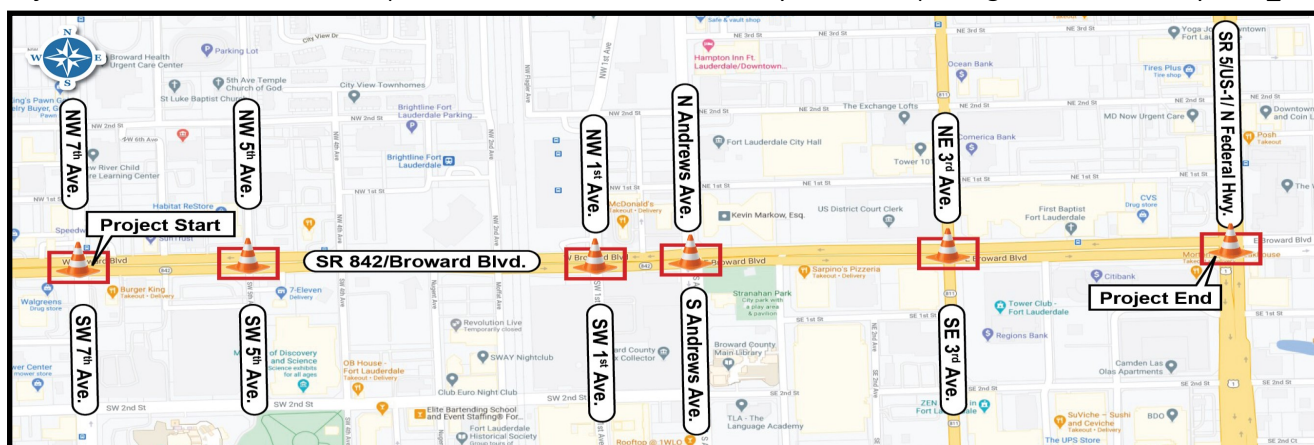
