## STATE ROAD 845/POWERLINE ROAD IMPROVEMENT PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information about the transit improvements for the Cypress Creek Tri-Rail Station at SR 845/Powerline Road and NW 59<sup>th</sup> Court in the City of Fort Lauderdale.

Construction Cost: \$589,516 Construction Start Date: November 12, 2020 Anticipated Completion: Spring 2021

#### **PROJECT IMPROVEMENTS**

- Constructing a directional median opening on Powerline Road to accommodate a bus-only left turn lane entering the Cypress Creek Tri-Rail Station
- Installing a new traffic signal to accommodate a left turn from NW 59<sup>th</sup> Court onto Powerline Road
- Installing new street lighting
- Modifying the irrigation system in the median
- Milling, resurfacing and adding pavement markings

9:00 a.m. to 4:00 p.m. 6:00 p.m. to 7:00 a.m.

- Pedestrian detours will be in place during sidewalk closures.
