### LIGHTING IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information regarding lighting improvements along SR 838/Sunrise Boulevard and SR A1A/SE 17<sup>th</sup> Street/Seabreeze Boulevard. The improvements will take place in the cities of Plantation, Lauderhill and Fort Lauderdale in Broward County, Florida.

#### PROJECT IMPROVEMENTS

- Upgrading existing roadway lighting with new LED fixtures to provide efficient light distribution, save energy and reduce maintenance costs
- New LED lighting will be installed at 8 intersections along SR A1A from Miami Road to Harbor Drive, 28 intersections along A1A from Sebastian Street to SE 13<sup>th</sup> Street and 15 intersections along Sunrise Boulevard

#### MAINTENANCE OF TRAFFIC

- Access to residences and businesses will be maintained at all times.
- Existing speed limits will remain in place.
- Lane closures will not be permitted during school speed zone hours.
- Sunrise Boulevard lane closures may occur: 8:00 p.m. to 7:30 a.m. Monday through Friday
- A1A lane closures may also occur: 8:30 p.m. to 7:00 a.m. Monday through Friday
