SR-5/US-1 BRIDGE OVER THE DANIA CANAL REHABILITATION PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information regarding the bridge rehabilitation of the SR-5/US-1 Bridge over the Dania Canal (Bridge Number 860001) in the City of Dania Beach.

PROJECT UPDATE

The water channel will be closed from 7 a.m. to 5 p.m., Monday through Friday, from Monday, November 28 to Thursday, December 22, for pile driving operations and the replacement of the fender system. The water channel will remain open on the weekends.

Construction Cost: \$895,595

Construction Start Date: November 2022

Anticipated Completion: Spring 2023

PROJECT IMPROVEMENTS

- Removing and replacing the existing fender system
- Rehabilitating the existing slope in the southwest corner of the bridge

TRAFFIC IMPACTS

- Old Griffin Road will be closed during pile driving operations, as needed. Traffic will be detoured using US-1, NW 1st Street, and NW 4th Avenue.
- Business, residential and pedestrian access will be maintained at all times.
