### SR 822/Sheridan Street Bridge Rehabilitation Project

The Florida Department of Transportation (FDOT), District Four will host an in-person Construction Open House and Virtual Public Meeting regarding the bridge improvements on SR 822/Sheridan Street Bridge over the Intracoastal Waterway (ICWW) in the City of Hollywood. **Construction Cost:** \$12,200,214

**Construction Start:** January 22, 2022

**Estimated Completion:** Late 2022

#### PROJECT IMPROVEMENTS

- Installing bicycle-friendly/anti-slip walking plates along the bridge moveable spans
- Removing existing curb and adding a 4-foot traffic railing between the sidewalk and roadway
- Removing and replacing the outer pedestrian railing
- Adding new pedestrian gates in each direction
- Renovating the existing tender house
- Upgrading electrical and mechanical components, and access platforms on the bridge

#### TRAFFIC & MARINE IMPACTS

- Single lane closures along the Sheridan Street over the ICWW are permitted Monday through Friday, between 10:00 a.m. and 4:00 p.m. and Sunday through Thursday night, between 8:00 p.m. and 6:00 a.m.
- Full closure of the bridge will occur for approximately a 90 day period, leaving it in the upright position for electrical and mechanical upgrades. Pedestrians and motorists will be detoured via the Dania Beach Boulevard Bridge and Hollywood Beach Boulevard Bridge. (Tentatively scheduled for the middle of April 2022 through the middle of July 2022; subject to change)
- Additional information about lane closures, detours, and marine impacts will be provided in the weekly traffic report distributed by FDOT.
